SUBJECT: THAT THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, RECOGNIZE AND OBSERVE OCTOBER 2022 AS LESBIAN, GAY, BISEXUAL, TRANSGENDER, AND QUEER (LGBTQ) HISTORY MONTH, AND DIRECT THE SUPERINTENDENT TO EXPLORE THE FEASIBILITY OF PROVING INFORMATION AND RESOURCES ABOUT LANDMARK SUPREME COURT CASES, INCLUDING OBERGEFELL V. HODGES (2015) AND BOSTOCK V. CLAYTON COUNTY (2020), FOR 12TH GRADE SOCIAL STUDIES CLASSES

The month of October has been established to remind all cultures within our wider community of the important roles that LGBTQ people have taken in shaping the social, historical, legal, and political worlds we live in today. A number of LGBTQ historical events and people of all races have contributed to the history of equality for all people, and LGBTQ individuals have made and continue to make lasting contributions to strengthen the fabric of American society.

Miami-Dade County Public Schools (M-DCPS) is firmly committed to school safety for all students, staff, and family members, including the Lesbian, Gay, Bisexual, Transgender, and Queer (LGBTQ) community, or those that may be perceived as such, and to creating a positive school climate by maintaining a safe environment and developing a sense of belonging for all students and staff. The District appreciates and recognizes the importance of LGBTQ History Month as an effective means of educating and calling to action our community to work together by fighting prejudice and discrimination in their own lives and increasing visibility and raising awareness.

As per Florida State Statute 1003.42, 2(f), students are required to learn about “The history of the United States, including the period of discovery, early colonies, the War for Independence, the Civil War, the expansion of the United States to its present boundaries, the world wars, and the civil rights movement to the present.” In 12th grade U.S. Government Courses, students learn about important Supreme Court Landmark cases that have shaped our country’s civil rights history. Specifically, under Next Generation Sunshine State Standards, SS.912.C.3.7, students are to describe the role of the judicial branch and its role in government. Providing information and resources for teachers who teach 12th grade social studies the opportunity to teach important landmark civil rights cases, including the Supreme Court cases of *Obergefell v. Hodges (2015)* and *Bostock v. Clayton County (2020)*, will allow for a better understanding of important civil rights legal protections for all Americans.

**ACTION PROPOSED BY
MS. LUCIA BAEZ-GELLER:**

That The School Board of Miami-Dade County, Florida:

1. Recognize and observe October 2022 as Lesbian, Gay, Bisexual, Transgender, and Queer (LGBTQ) History Month and direct the Superintendent to support policies and practices, consistent with provisions outlined in Policy 2240 and Policy 2260, that respect and support LGBTQ students and their families throughout the school year; and
2. Direct the Superintendent of Schools, in accordance with provisions outlined in Policy 2240 and Policy 2260, state curriculum standards, and all applicable state and federal law, to explore the feasibility of ensuring that M-DCPS has information and resources available for teaching landmark supreme court cases for 12th grade social studies teachers, including *Obergefell v. Hodges (2015)* and *Bostock v. Clayton County (2020)*, in their 12th grade social studies class. Nothing in this item requires a teacher to include *Obergefell v. Hodges (2015)* and *Bostock v. Clayton County (2020)*
