Clovis Community College President Jonathan Fuentes reported that enrollment rose at the college 6.1% from last year. He stated that CCC Administrators expect to lobby for additional funding for the college in Santa Fe during the upcoming 60-day legislative session.

Quay County was seeking funding to complete the new Trigg Memorial Hospital in Tucumcari. Initially, the county sought \$20 million funding through the U.S. Department of Agriculture. Delays in funding led them to instead apply for financial aid from the New Mexico Finance Authority.

The first case of measles was confirmed in New Mexico after it was identified in an unvaccinated Lea County teenager. Health Department officials believe that the measles originated from the ongoing measles outbreak in bordering Gaines County in Texas. Viewers were given information on a free vaccination clinic in Lea County happening the following week.

#### D: Governmental -

Viewers were informed of the upcoming end to the New Mexico Legislative Session in Santa Fe. Any bills that reach the Governor's desk can be signed or vetoed until April 11, with any bill that isn't acted upon by the governor being pocket vetoed. Viewers were encouraged to keep their eye on any bills of interest.

Residents of Curry County were informed that the county's DWI Task Force was conducting a virtual meeting on February 14 at 2 PM. They were given the information necessary to request an invite if interested in attending.

Preparations for the fire season in New Mexico began as conditions throughout the state were expected to produce a challenging fire season. Strategies like prescribed burns play a huge role in preventing disastrous wildfires that can cause immense damages to life and property.

Carlsbad implemented a temporary plastic bag ban in an effort to reduce litter. The ban applied to single-use carryout bags provided at the point of sale in grocery stores, restaurants, and other businesses. The ban went in effect for a two-year trial, and is enforced by the city of Carlsbad through fines for noncompliant businesses.
