**FINAL JUDGMENT**

The plaintiffs' motion for default judgment with respect to claims against Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C. is **GRANTED**. There are claims for relief against the other parties in this case, and the court specifically certifies that there is no just reason for delay of the entry of final judgment as to the defaulting parties listed above. Based on the foregoing, the court orders that:

Plaintiff Ross Kawamoto recover the sum of \$76,856.24 and his costs of court from the defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally, and

Plaintiff Jerry Stone recover the sum of \$38,428.12 and his costs of court from the defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally, and

Plaintiff Rafael Madrigal recover the sum of \$76,856.24 and his costs of court from the defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally, and

Plaintiff Bill Cokley recover the sum of \$153,643.25 and his costs of court from the Defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally, and

Plaintiff Stan Kawamoto recover the sum of \$76,856.24 and his costs of court from the defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally, and

Plaintiff Dan Lasky recover the sum of \$38,428.12 and his costs of court from the defendants Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C., jointly and severally.

The plaintiffs also requested reasonable attorney fees and filed an affidavit proving attorney fees in the amount of \$5000. The court orders Iceport Foundation, Inc., Scott Branovan, Sportscomm Cudahy L.L.C., Branovan Family, L.L.C., Slapshot Hockey, L.L.C., Iceport Leasing, L.L.C., and Sportscomm Venues, L.L.C. pay the plaintiffs \$5000 for attorneys fees.

Post judgment interest is payable on all the above amounts allowable by law at the rate of 5.03% per annum from the date this judgment is entered until the date this judgment is paid.

The court orders execution to issue for this judgment.


