I never knew what they were doing or where I stood with either law firm.

I am not a Lawyer and i don't have any guidance at this point. Please don't opt me out.

Please help me. I didn't deserve the way I was teated and I expressed feedback to them when they would ignore me and not call me back. They are in this for the money for themselves, I felt like information was intentionally hid from me and communication was zero intentionally by Attorney, Andrew D. Downing and Carlson Law Firm.

I am not a repeat Claimer and as I stated to Attorney, Andrew D. Downing and Carlson Law Firm I have birthed 8 children. 4 boys and 4 girls, last named Keithsharia passed away so I raise 7 children and I never had to file a claim like this before for any of my other children but this one child due to this Gardesil Vaccine that again I was bullied into giving to my child that is still suffering daily years later.
