KANW has numerous facilities serving Eastern, Northern, Western and Central New Mexico, with our FM service, our HD service, one primary radio station, four repeater radio stations and four translator stations.

KANW-2, KANW's second station also has numerous facilities serving Eastern, Northern, Western and Central New Mexico. KANW-2 is KANW 89.1 HD2 primary radio station, one repeater radio station and three translator stations. KANW's coverage area includes many rural and underserved minority communities in Eastern, Northern, Western and Central New Mexico.

KANW serves as the Primary 2 EAS service for the state of New Mexico. Providing critical EAS tests and announcements to urban and rural, minority and underserved communities.

KANW works within all the communities we serve through ascertainment meetings, community outreach during cultural celebrations, fiestas, and Matanzas, throughout the year. We regularly review our programming to ensure it is meeting the needs of all New Mexicans in the communities we serve.

An annual service we provide to all our communities is the broadcast of the Governor's State of the State Address, bringing this address to many rural, minority and underserved communities that would otherwise not hear the Governor's address.

KANW annual broadcast of the President's State of the Union Address. This broadcast serves the rural, minority and underserved communities that would otherwise not hear this address.

KANW coverage of national and international news to rural, minority and underserved communities in New Mexico.

KANW continues its proud tradition of being the venue for New Mexico music and maintains our associate with the New Mexico Latin Music Association and the New Mexico Hispano Music Association, New Mexico Cultural Affairs Department, New Mexico Tourism Department. These relationships help preserve New Mexico's rich music heritage, and the rich diverse culture in New Mexico. KANW broadcasts New Mexico music daily, Native American and Celtic Music weekly.

KANW collaborates with the New Mexico Department of Cultural Affairs and New Mexico Department of Tourism during our membership campaigns. Promoting New Mexico historical and cultural sites, cultural heritage and New Mexico Magazine.

KANW is a media sponsor for the Albuquerque Hispano Chamber of Commerce gala and annual meeting. KANW continues to collaborate with the Albuquerque Hispano Chamber of Commerce.

As a member of the New Mexico Broadcasters Association (NMBA) KANW staff attends ascertainment meetings, in Albuquerque, to understand the issues, problems, needs and wants of our community, as offered by the NMBA.

KANW Staff works with communities in our broadcast area including Grants, Gallup, Bernalillo and Santa Rosa to meet with community members obtaining ascertainment meetings to have a better understand the issues, problems, needs and wants of the communities at large.

KANW is a member of the Albuquerque Economic Forum.

KANW continues to increase our presences with all forms of social media, live remotes, fiestas, and events in communities throughout Eastern, Northern, Western and Central New Mexico.

KANW and KANW-2 produces and broadcasts New Mexico news on the hour Monday through Friday, from 4am to Noon, and afternoons at 4pm and 5pm.

During FY22 KANW produced and broadcasted 459 programs/features to educate New Mexicans about issues and concerns and provide community outreach and educational material to all listeners in Eastern, Northern, Western and Central New Mexico. 7/5/2021 REPORT FROM SANTA FE In this in-depth interview, discussing his new book, Arkin tells powerful stories of some of the "miracles" that he has encountered on his odyssey. Arkin has accomplished a delightful balance between the everyday and the cosmic, and his charming humanity is seen in this manifesto -- two truisms that sum up a possible meaning of life: I) everything changes. 2) There is no such thing as too much garlic. This humorous juxtaposition shows Arkin's rare balance of humanity and spirituality.

Alan Arkin has starred on Broadway, TV, over sixty films, and has won almost every acting award in North America. In this, his ninth published book, with his characteristic wry humor, he digs into his long-time search for meaning, past the seductive glamour of show business. By the time he was in his early thirties, his career was in full bloom and he had achieved everything he had ever thought he wanted, only to find that it was not what he had hoped for.

In "Out of My Mind," Arkin speaks openly about the existential crisis, which brought him from analysis to the serious study of Eastern Philosophy, and several teachers who helped him revise his views on almost everything. In this sort-of memoir, the 86-year-old actor tells of the adventures, which, as a direct result of decades of meditation, shook his conception of reality and brought him to a new, exciting, and expanded view of what is "out there," and the endless, mind-boggling adventure into what is possible – not just for himself but for all the rest of us.

7/12/2021 REPORT FROM SANTA Stuart Ashman, CEO of the International Folk Art Market, describing this year's COVID-safe outdoor folk art market held in Santa Fe, NM. The structure and format of this year's Market has dramatically changed to ensure participants', attendees', and buyers' safety.

It will also create a far more open and less congested event, aligning with the CDC and State of New Mexico's guidelines.

The first big change? It will not be limited to one weekend.

This year, the International Folks Art Market will take place July 7-11 and 14-18.

As of this writing, spots for the first weekend have sold out. Tickets for the second weekend are going fast. · All entries will be for a set time, and each ticket will be for an allotted shopping time of two hours.

- · IFAM Staff will clear the venue between each session, to allow for the implementation of COVID-Safe Practices.
- · A different group of artists will participate each week.
- · Mask wearing will be mandated. On July 16, 2020, beginning at 5:20 a.m., there will be an event in Albuquerque's Civic Plaza to memorialize the75th anniversary of the Trinity Bomb Test. The event will be live-streamed and will include a countdown much like what took place on July 16, 1945.

7/19/2021 REPORT FROM SANTA FE Michael McGarrity, bestselling New Mexican author and former law enforcement officer, discussing "Head Wounds," the latest and last novel in his popular Kevin Kerney series.

McGarrity's eighteen crime novels take place in modern New Mexico, with law enforcement officer Kevin Kerney as the protagonist. The settings are vividly evoked and range from the Tularosa Basin and Lincoln County to Hermit's Peak, although many take place in Santa Fe. "Hard Country," "Backlands," and "The Last Ranch" form a sweeping trilogy tracing the Kerney family's history in New Mexico from 1875 through the end of the Vietnam War. A groundbreaking prequel trilogy, all three books are set on the Tularosa Basin of south Central New Mexico.

McGarrity has received many honors and awards:

New Mexico Social Worker of the Year, 1980

Santa Fe's Police Officer of the Year, 1987

New Mexico Governor's Award for Excellence in the Arts - Literature, 2004

Santa Fe Mayor's Award for Excellence in the Arts - Literature, 2015, and

The Frank Waters Exemplary Literary Achievement Award, 2015.

McGarrity has been nominated three times for the Western Writers of America Spur Award for Best Western Novel as well as an Anthony Award for his debut novel, "Tularosa."

7/26/2021 REPORT FROM SANTA FE Dr. David Scrase, doing double duty as Cabinet Secretary for the NM Dept of Health, as well as Cabinet Secretary for the NM Dept of Human Services. Dr. Scrase provides a timely update on the ever-changing Covid-19 pandemic in New Mexico.

Dr. Scrase notes, "The virus is a tough opponent!" He offers the most up-to-date information on New Mexico's reopening; masking questions; back-to-school issues; and what New Mexicans need to know to successfully navigate this next phase in the pandemic.

Dr. Scrase discusses New Mexico's current vaccination rate - 64.1 % of New Mexicans are fully vaccinated and 72.1 % of New Mexicans 18 and older have had at least one shot. (These continually updated numbers are current as of 7/21/21).

He presents the percentages of people hospitalized or dead from COVID-19 in New Mexico -

- · "About 96% of all COVID-19 cases have been in people who are not fully vaccinated,
- $\cdot$  95% of hospitalizations are in patients who have COVID, but have not been fully vaccinated, and then  $\cdot$  98% of deaths from COVID are in people who have not been fully vaccinated."

Another important topic of discussion is the Delta variant and the dangers it presents in terms of its increased transmissibility and virulence.

Scrase explores the dangers of misinformation and disinformation about the virus and the vaccine.

He also reveals the new phase in the efforts to reach more New Mexicans with vaccine availability with the new Take Care New Mexico program, a campaign to get primary care providers to also be vaccine providers as patients return to their primary care providers to resume regular care after the pandemic hiatus.

Other coronavirus hot topics are kids returning to school in the fall and the questions of masks, vaccines, teachers being vaccinated, etc. Dr. Scrase also explains the issue of "breakthrough" infections in people who are fully vaccinated.

8/2//2021 REPORT FROM SANTA FE Stephanie Garcia Richard, New Mexico's Commissioner of Public Lands. Garcia Richard was elected to the office of NM Land Commissioner in 2018 and is the first woman and the first educator in this very important role. She explains her deep connection to the role, "because it is the office that raises money for education, (I felt that) that an educator would really know the value of every dollar, every dime really that the Land Office earns."

The purpose of the Land Office is to fund public education and other public institutions. Commissioner Garcia Richard is tasked with overseeing 9 million surface acres and 13 million mineral acres.

Income is generated by leasing state trust land for a multitude of purposes including oil and gas, renewable energy, agriculture, and a broad array of commercial uses. The beneficiaries of these funds were laid out in the New Mexico Constitution and include NM schools, hospitals, and colleges.

The Land Commissioner proudly notes that this year, "We are announcing a historic billion dollars worth of revenue that we have raised on behalf of the citizens of New Mexico that will go to our public schools, universities, and hospitals. But what your viewers really want to know, is that will save the average taxpaying household \$1500 a year in taxes that they don't have to pay to support their schools and universities and hospitals."

Commissioner Garcia Richard describes the "Open for Adventure" program at the Land Office that features beautiful NM state trust lands available for outdoor recreation such as Melrose Woods, San Lorenzo Canyon, and White's Peak. She adds, "We manage lands that anywhere else could be a state park or a national park. I mean these are some of the most pristine, gorgeous landscapes that you could experience and we manage them under state lands." She highlights a number of destinations and locations for people to come out and recreate for bird watching, fishing, hunting, hiking, and more.

8/9/2021 REPORT FROM SANTA FE Cheryl Alters Jamison, one of America's premier food writers, cookbook author, authority on American regional cuisine, and winner of four James Beard Foundation Awards. Her books, such as "Smoke and Spice," "Tasting New Mexico," and "Texas Q," have sold over 2 million copies.

8/16/2021 REPORT FROM SANTA FE Doug Preston, journalist, and author of 36 books, 30 of which were New York Times-bestsellers. He is as well known for his famous techno-thrillers from "Relic" to "The Scorpion's Tail." And his non-fiction works such as "The Monster of Florence" and "The Lost City of the Monkey God."

8/23/2021 Report from Santa Fe" Environmental journalist and author Laura Paskus speaking about her book "At the Precipice: New Mexico's Changing Climate," the severe drought the American Southwest is experiencing, and other critical climate issue

8/30/2021 REPORT FROM SANTA FE Author Anne Hillerman, discussing her new book "Stargazer," the sixth in her Bernadette Manuelito series of mysteries set in the Navajo country of her father Tony Hillerman's popular thrillers starring Jim Chee and Joe Leaphorn.

9/6/2021 REPORT FROM SANTA FE Kyle Dickman, journalist and author of "On the Burning Edge: A Fateful Fire and the Men Who Fought It." Dickman discusses California's ferocious wildfire season and explores why these wildfires seem so out of control. He also describes his work as a former editor of Outside Magazine with topics as far ranging as rattlesnake bites, antivenom, antibodies, and more.

Among her awards and honors are the National Book Award, the National Humanities Medal, O'Henry Awards, Pulitzer Prize nominations, and more. Oates was christened America's foremost "woman of letters" by John Updike.

9/20/2021 REPORT FROM SANTA FE Photojournalist and author Don Usner discussing his recent online photo collection "Our Lives Now: A Photographic Journal of Life during the Pandemic," presented in partnership with Searchlight NM. Usner also describes his popular books "Sabino's Map," "Orale! Lowrider: Custom Made in New Mexico," and "Valles Caldera: A New Vision for New Mexico's National Preserve."

9/27/2021 REPORT FROM SANTA FE Mario Jimenez III, the former chief deputy county clerk in Dona Ana County, now working on election issues with Common Cause NM, discussing serious threats experienced by election workers, voter intimidation, and maintaining the integrity of our elections.

Mario Jimenez has 17 years of experience navigating elections, from working elections in the county clerk's office in Dona Ana County, to serving twice as president of the County Clerks affiliate, where he helped set up New Mexico's Voter Convenience Centers. He also is a member of the Voting Systems Certification Committee, where he helped make the voting machines more user-friendly by becoming ADA compliant and more efficient, and is certified as a voting machine technician who can program and repair voting machines, so has practical, on-the-ground knowledge.

Jimenez discusses many instances of New Mexican election administrators and poll workers being intimidated and receiving death threats while trying to perform their duties as election officials. False accusations that they were liars and thieves, racist emails, and threats on their lives made their work extremely unsafe for anyone working to staff election precincts and voting locations.

Even New Mexico's chief elections officer, Secretary of State Maggie Toulouse Oliver received so many threats to her safety that she left home for weeks after the 2020 election and had to have police protection due to death threats. Her name and personal information were published on a website called "Enemies of the People" with a target superimposed on her photograph. She is working on ways to safeguard the country's elections with a national council partnering with the US Dept. of Homeland Security.

This dangerous trend can be observed nationally as well as locally. The promotion of the Big Lie regarding the 2020 election, has not only encouraged fanatical behavior among some disgruntled voters, but also tarnished and eroded the faith Americans have in their voting and elections systems.

New Mexicans can be proud that this state is one of the best in the nation for election integrity and the paper ballot system provides completely trackable and easily auditable voting records. It is important that we make the elections environment a safe space for our election officials to work in without fear of harm.

10/4/2021 REPORT FROM SANTA FE Kathy Flynn, Executive Director of the New Deal Preservation Association and its New Mexico chapter, discussing the abundance of WPA Art (Works Progress Administration) to be seen in New Mexico, and the legacy it represents.

10/18/2021 REPORT FROM SANTA FE Bobbi Heller, Felines and Friends NM, and Murad Kirdar, Santa Fe Animal Shelter, discussing the impending crisis for families and pets when the COVID Eviction Moratorium is lifted, as well as the issue of NM's homeless animals. New Mexico is currently experiencing an unprecedented situation at all animal shelters and rescue operations. Every one of them is at capacity and has an excess of animals. This is due in part to the pandemic. Spay and neuter surgeries were not deemed as essential and so overpopulation quickly hit local animal shelters. These shelters are promoting free adoptions and volunteer fostering of these animals that are overwhelming the system. Bobbi Heller, the executive director of Felines and Friends New Mexico, and Murad Kirdar, who is the public relations and business relations officer for the Santa Fe New Mexico Animal shelter, serve as "rescue partners" for the many New Mexico homeless and injured or sick animals. Although both groups are based in Santa Fe, they partner with community shelters all over the state. The Santa Fe Shelter has a program, "Driving Change to Save Lives," where they bring in at-risk animals from 40 community shelters to the Santa Fe Shelter, freeing up limited resources so that smaller shelters can continue to help animals in their own community. Kirdar notes that over the last ten years, the Santa Fe Animal Shelter has partnered with over 40 of New Mexico's shelters and rescues to transfer over 3,500 animals.

Heller and Kirdar point out that when the COVID Eviction Moratorium is lifted, many landlords will probably be eager to evict some tenants, while raising the rent on others. Many tenants will be faced with finding new homes and may experience difficulty finding new living arrangements that will allow them to keep their family pets. Many of those pets will then be surrendered to shelters already operating at maximum capacity.

To try to get pet owners to stop and look for alternatives, the Animal Shelter has changed the vocabulary for pet surrenders by getting rid of the term "owner" and using the term "guardian" because when one owns something, it is much easier to get rid of it, but when one is a guardian of a cat or a dog, they think twice.

10/25/2021 REPORT FROM SANTA FE James McGrath Morris discussing his newly-released biography of New Mexico's beloved author Tony Hillerman, "Tony Hillerman - A Life."

11/1/2021 REPORT FROM SANTA FE Author Sandra Cisneros. Cisneros is an internationally renowned Latina novelist, poet, and activist, most famously known for authoring "The House on Mango Street" and honored with the National Medal of Arts, conferred upon her by President Obama.

Additional books by Cisneros include: "A House of My Own: Stories of My Life," "Woman Hollering Creek," "Carmelo," Have You Seen Marie?" and "My Wicked, Wicked Ways." Among her many honors, Cisneros is a MacArthur Genius Fellow and earned the National Medal of the Arts Award from President Barack Obama. Cisneros celebrates the 40th anniversary of her iconic novel The House on Mango Street, which now has sold seven million copies and is available in twenty languages. She celebrates a new translation of "Mango Street" coming out this year. She is also working on an opera based on "The House on Mango Street."

11/15/2021 REPORT FROM SANTA FE New Mexico Secretary of State Maggie Toulouse Oliver. For the first time speaking publicly in an in-depth interview, Oliver discusses the fallout from the 2020 election, and the intimidation and threats to elections officials in N.M. and nationwide.

The Secretary of State describes the death threats made to her personally at the time of the 2020 election, and the steps she took against them in conjunction with the FBI, the Department of Homeland Security, and the State Police.

She reveals the surprising source of those threats, as determined by the FBI, and how the bounty on her and other national elected officials was to be paid. This week marks one year since the 2020 election, and the one-year anniversary of the initiation of the "big lie," which wrongfully casts suspicion and doubt on the integrity of our elections. Toulouse Oliver analyzes the many laws passed in many states to actually suppress voting and other manifestations of what many observers see as an attack on democracy.

She presents ways we can proactively protect our elections officials in the next election because it is not just secretaries of state around the country that are threatened -- it is county clerks, local county and city election officials, and even volunteer poll workers.

Maggie Toulouse Oliver is the Chief Elections Officer for New Mexico and was elected to the office of NM Secretary of State in 2016. She served as the President of the National Association of Secretaries of State and describes the intimidation and threats to election officials across the nation, telling many frightening stories about her colleagues, both Republican and Democrat, in Michigan, Arizona, Utah, Georgia, and more.

"The stories from my colleagues are in many cases quite tragic," explains Oliver. "My colleague, Jocelyn Benson (D) who is the secretary of state in Michigan, literally can't leave her home without police protection. She has a young child at home, (and) not a week goes by where there isn't somebody that shows up with a gun outside of her home. My dear friend, Barbara Cegavske (R), who is the Nevada Secretary of State, her biggest concern has been the threats that have come in to her staff. And she says that time and time again that it is not just about focusing on her, it is about focusing on the staff."

"And of course, Brad Raffensperger in Georgia really has had to deal with untold scariness over the last two years," continues Oliver. Georgia is impaneling a special grand jury to prosecute the election interference of former President Trump, who called Raffensperger and illegally demanded, in a recorded call, "I want you to find 11,780 votes."

Oliver also is part of a national group, the "Government Coordinating Council for Critical Infrastructure for Elections," which works together with the Department of Homeland Security to ensure that our elections are maintained as critical infrastructure.

New Mexico has an outstanding reputation for election integrity and uses unhackable paper ballots in its elections. The Secretary of State predicts some delays in New Mexico's decennial redistricting due to the lateness of U.S. Census data being released to the states. This will affect candidates running in many districts whose boundaries will be redrawn by the NM Legislature in December.

11/22/2021 REPORT FROM SANTA FE Don Hancock, Director, Nuclear Waste Program, Southwest Research and Information Center, discussing the Waste Isolation Pilot Plant (WIPP) in southeastern New Mexico, its history, and the development of a new mission for the facility. In this interview about such complex subjects, Don Hancock provides scientific sources for information about WIPP and its new mission, as well as references to solid scientific reports, such as the National Academy of Sciences 200-page report on "Disposal of Surplus Plutonium in the Waste Isolation Pilot Plant."

Hancock suggests that New Mexico use its consultation and cooperation rights, which require the Department of Energy to provide the state and the public with information about what it is going to do, before it makes major changes to WIPP, so that the state and the public have the right to participate. New Mexico also has authority to issue a permit for WIPP under the state's hazardous waste act, which would decree how long WIPP will operate and what materials can be put underground at WIPP.

WIPP is the nation's only deep geologic long-lived radioactive waste repository. Located 26 miles southeast of Carlsbad, New Mexico, WIPP permanently isolates defense-generated transuranic (TRU) waste 2,150 feet underground in an ancient salt formation. Transuranic waste to be disposed of at the WIPP comes from the department's nuclear weapons programs. This waste consists primarily of clothing, tools, rags, debris, residues and other non-liquid disposable items contaminated with trace amounts of radioisotopes.

The Energy Department (DOE) issued a notice of intent in December 2020 to begin the process for an environmental impact statement as one of the first steps toward diluting and disposing of plutonium left over from the Cold War. As the National Academy of Sciences (NAS) report points out, the proposed disposal of 48.2 metric tons of diluted plutonium substantially changes the mission of WIPP.

Also, as the NAS discusses, this change in WIPP's mission significantly changes the WIPP "social contract" with the state of New Mexico. NM elected officials and regulatory agencies must ensure that all WIPP safety issues are properly addressed and enforceable in a revised social contract.

These proposed plutonium shipments include plans to truck plutonium shipments through New Mexico, including Santa Fe's southern edge, and are deeply concerning to New Mexico lawmakers. The shipments would travel through a dozen states and cover 3,000 miles. The issue of such a drastic change in mission for WIPP does represent fundamental exposure to citizens of the state, and citizens have a right to know exactly what the new plan is for WIPP.

New Mexico is currently experiencing an unprecedented situation at all animal shelters and rescue operations. Every one of them is at capacity and has an excess of animals. This is due in part to the pandemic. Spay and neuter surgeries were not deemed as essential and so overpopulation quickly hit local animal shelters. These shelters are promoting free adoptions and volunteer fostering of these animals that are overwhelming the system.

Bobbi Heller, the executive director of Felines and Friends New Mexico, and Murad Kirdar, who is the public relations and business relations officer for the Santa Fe New Mexico Animal shelter, serve as "rescue partners" for the many New Mexico homeless and injured or sick animals. Although both groups are based in Santa Fe, they partner with community shelters all over the state. The Santa Fe Shelter has a program, "Driving Change to Save Lives," where they bring in at-risk animals from 40 community shelters to the Santa Fe Shelter, freeing up limited resources so that smaller shelters can continue to help animals in their own community. Kirdar notes that over the last ten years, the Santa Fe Animal Shelter has partnered with over 40 of New Mexico's shelters and rescues to transfer over 3,500 animals.

Heller and Kirdar point out that when the COVID Eviction Moratorium is lifted, many landlords will probably be eager to evict some tenants, while raising the rent on others. Many tenants will be faced with finding new homes and may experience difficulty finding new living arrangements that will allow them to keep their family pets. Many of those pets will then be surrendered to shelters already operating at maximum capacity.

To try to get pet owners to stop and look for alternatives, the Animal Shelter has changed the vocabulary for pet surrenders by getting rid of the term "owner" and using the term "guardian" because when one owns something, it is much easier to get rid of it, but when one is a guardian of a cat or a dog, they think twice.

He is contributing editor at Adventure Journal Quarterly, and his writing has appeared in the New York Times, Los Angeles Times, Men's Journal, and Outside.

4/4/2022 REPORT FROM SANTA FE Representative Debbie Armstrong, D- Bernalillo, former chair of the NM House of Representatives Health and Human Services Committee, discussing recent legislation affecting the health of New Mexicans.

In this in-depth interview, Rep. Armstrong discusses what New Mexico legislators have been doing to facilitate a clearer path to health for New Mexicans.

She reveals how the N.M. state legislature affects our individual medical choices and options, by implementing the health affordability fund, the high-risk insurance pool, replacing a federal tax with a New Mexico tax to make medical insurance more affordable, passing laws to allow buying prescription drugs from Canada, and work to minimize the effects of medical debt. Armstrong describes her efforts to pass the Elizabeth Whitefield End of Life Options Act, a groundbreaking piece of legislation -- now a national model for other states as they craft similar "death with dignity" legislation.

She has been a long-term healthcare advocate and has served four terms in the House of Representatives in New Mexico. She started as a physical therapist, then got a law degree from UNM, and taught bioethics there. Debbie served as the cabinet secretary for the New Mexico Aging and Long Term Care Services Department. She is also a businesswoman, president of Delta Consulting Group and the Executive Director of the New Mexico High Risk Insurance Pool.

4/11/2022 REPORT FROM SANTA FE Dr. Estevan Rael-Galvez, historian, cultural anthropologist, and former New Mexico State Historian, discussing his current project "Native Bound, Unbound: Archive of the Indigenous Enslaved."

His project, "Native Bound, Unbound Archive of the Indigenous Enslaved," has received a \$1.5 million grant from the Mellon Foundation. The project intends to build a digital repository that is

part-database, so the public will be able to identify the names, the dates, the artifacts of indigenous people who were enslaved from 1495, all the way to the 20th century.

Rael-Galvez is gathering documents, photos, stories, artifacts, to be made accessible through a digital portal. The story of the indigenous enslaved extends far beyond New Mexico, to include a hemispheric and global scope.

Dr. Rael-Galvez has nearly two decades of experience as a senior executive, strategist and scholar with a range of public and private sector entities. Having received both his M.A. and Ph.D. from the University of Michigan in Ann Arbor, his academic training is in cultural anthropology, history, and literature.

Rael-Galvez served as the State Historian of New Mexico from 2001-2009, Executive Director of the National Hispanic Cultural Center from 2009-2011, Senior Vice President of the National Trust for Historic Preservation from 2011-2014, and as founder and director of Creative Strategies 360 Degrees from 2014 to the present.

4/18/2022 REPORT FROM SANTA FE Jill Dixon, Deputy Director of the Food Depot, Northern New Mexico's food bank. The Food Depot is one of five food banks in New Mexico and the only food bank serving the nine northern most counties in New Mexico. Dixon describes the effects of the pandemic on their services. She states, "What the pandemic really did is far as food banks are concerned, is strip away that veil that we were hiding behind that hid that reality of our economic fragility. And hunger is just a symptom of poverty and if we learn nothing else, it is that you can't cure hunger unless you are systemically addressing poverty."

4/25/2022 REPORT FROM SANTA FE Stephanie Garcia Richard, the Commissioner of Public Lands for the State of New Mexico, discussing the billion-plus dollars raised annually from the extractive industries in NM that is given to the beneficiaries of the Land Grant Permanent Fund and used to pay for public schools, universities, and hospitals. Commissioner Stephanie Garcia Richard is the first woman, the first Latina, and the first educator to serve in the position as New Mexico's Commissioner of Public Lands.

Based on her experience and training as a psychiatrist, Dr. Wang suggests that racism should be treated as a mental illness, and as a factor, that causes mental illness. She evaluates the national history of racism and racist events and looks closely at New Mexico's history of racism. She reviews racist language that was embedded in the New Mexico Constitution and in Albuquerque property, deeds and the efforts made to overturn this form of discrimination.

Dr. Wang makes a provocative case for the fact that diversity in New Mexico is not so diverse, and details the economic consequences of this, as the world enters a more global economy in the 21st Century. "I just envision a New Mexico without racial hierarchies," Wang states." I envision a New Mexico where New Mexicans are proud of their mixed-race heritage. And New Mexico has to stop wanting to be an outpost of Old Spain, and to move forward into the 21st century."

Just this week, President Biden signed a bill aimed at addressing the rise in anti-Asian hate crimes. Dr. Wang serves as the president of the Caucus of Asian American Psychiatrists, under the auspices of the American Psychiatric Association (APA). She recently participated in a forum on the "Mental Health of Asian-Americans and Pacific Islanders during COVID and the Rise of Xenophobia" where she discussed national incidents of anti-Asian hate, which have provoked so much fear and anxiety in the Asian-American community. In the past year, since the COVID pandemic started, there have been over 4,000 reported incidents of hate crimes and attacks against Asians-Americans. Many such crimes go unreported due to the victims' fear and shame. Dr. Wang explores the many causes and effects of these hate crimes nationally.

A graduate of the Yale School of Medicine and the UCLA Neuropsychiatric Institute, Dr. Wang has been on the faculty of the University of New Mexico (UNM) School of Medicine, training students of psychiatry since 1998. She completed an MA in English Literature from the University of California, Berkeley, with an emphasis in ethnic American literature and the

history of medicine. She is the author of The Kitchen Shrink and The Daily Practice of Compassion: A History of the UNM School of Medicine.... She hosted Duke City Magazine on New Mexico GOV-TV for eight years.

5/23/22 REPORT FROM SANTA FE Bobbie Heller, Executive Director, Felines and Friends NM, and Murad Kirdar, Public Relations Officer, Santa Fe Animal Shelter discussing rescue and shelter provisions for animals displaced by New Mexico's wildfires.

Heller and Kirdar address the entire evacuation situation - particularly people who are evacuating their animals. They describe the distressed refugee traumatized animals that they are taking in from people who have lost their homes or have been evacuated.

It is important, if you are in the "ready' mode, to get your animals out ahead of time. The Santa Fe Shelter, and Felines and Friends, are taking in cats and dogs. Santa Fe Cats on Tano Road last week had 26 or 27 cats, plus they took a litter of kittens abandoned when the mother ran away due to smoke.

Heller and Kirdar suggest that all pet owners prepare a grab-and-go bag for each one of their pets containing a recent photo of the animal, food, water, a food dish and a water bowl, an extra collar and leash, medicines if needed, health and vaccination records, a towel, cat litter and a litter pan, favorite toys, and a first-aid kit.

There are also many organizations focused on assisting evacuated large animals and livestock. These include both the Santa Fe and Albuquerque fair grounds, where ranchers and farmers can bring their animals.

One of the biggest challenges is the fact that New Mexico has had multiple fires with evacuations at the same time. Now there are people coming from different areas and they need a place to move with their animals.

At present, the animal rescue situation faces a perfect storm. With the fires going on all around New Mexico, and with kitten and puppy season also in full swing, it is a confluence for shelters and rescues across the state. Santa Fe Animal Shelter has welcomed in animals from Las Vegas, Pecos, and Los Alamos. All of New Mexico's animal welfare groups are working together for the good of the animals.

She observes that we can diversify the revenue that comes into the Land Office by tripling the number of renewable energy projects, promoting outdoor recreation, and encouraging new and innovative commercial development on state trust land.

With the largest continuous oil and gas resources potential ever assessed in the world sitting in Southeast New Mexico, and land that is prime for wind and solar development, Commissioner Garcia Richard reaffirms her commitment to working to make more money for New Mexico while always keeping an eye toward stewardship and preserving the land for generations to come.

The aging process has been an inspiration for Randall and she writes about how growing old is something that we have learn how to do. And it's a steep learning curve. Randall comments, "We lose so many abilities, so much agility and so forth. But for me, age, at least to this point, has also been quite marvelous. It has given me the opportunity to sit with myself, to think about my life, and the life of people I love...So I approach aging in a complex way, I try to write about it honestly with its ups and downs, but I also write about it admiringly."

Governor Michelle Lujan Grisham Governor Michelle Lujan Grisham is requesting federal approval of a disaster declaration as wildfires continue raging throughout New Mexico. The governor made the announcement in a news conference Tuesday morning in Santa Fe, highlighting five major, active wildfires burning across six counties in the state. Governor Lujan Grisham said Tuesday that typically, federal declarations don't occur until "after the emergency is dealt with," due to high-level efforts identifying the amount of property loss that's occurred. "I'm unwilling to wait," the Governor said, highlighting how firefighters have been working on wildfire operations in New Mexico for the last month.

"We're going to be the very first state in the nation to have a presidential declaration accepted and signed by the president unlocking all of these resources for watershed recovery, restoration of all of those wildlands and personal, direct, financial reparation and assistance before the fire is out," she said. "We are submitting this today, the president is very clear that is coming and we have every indication that we'll be the first state to advance this request."

Federal disaster teams designated to help New Mexicans recover from wildfire damage are starting work in Glorieta and Ruidoso even as local emergency managers issue dire warnings for extreme weather this weekend that's expected to make firefighting difficult.

Gov. Michelle Lujan Grisham and other officials gave a news update Friday morning, during which the governor both outlined plans for assistance and emphasized the foreboding weather report, especially for the Hermits Peak/Calf Canyon fires burning near Las Vegas.

"The projected data is about 11 am tomorrow, for 100 straight hours, we will have high temperatures and extreme winds. This is the worst possible set of conditions for any fire. Governor Michelle Lujan Grisham, New Mexico Gov. Michelle Lujan Grisham said Tuesday that it was "negligent" for the United States Forest Service to ignite a prescribed burn in early April, and that she has received assurances that there will be no more prescribed burns in New Mexico in the short-term — at least not while fires continue to rage here.

"So no one has to worry about that. That's been made very clear to our partners: We're done," she said. "And nothing happens except fighting these fires, and providing recovery assistance to New Mexicans."

A Santa Fe National Forest crew on April 6 ignited what was supposed to be a 1,200-acre prescribed burn in Las Dispensas, south of Mora. It quickly jumped out of the burn area and caused the Hermits Peak wildfire, which has since merged with the Calf Canyon fire and burned more than 200,000 acres.

At a news briefing Tuesday, Lujan Grisham said she shares the anger felt by many New Mexicans about the prescribed burn gone awry. But she said it was an "earnest mistake," one she expects the federal government to pay for in addition to federal disaster relief.

"For me, it's negligent to consider a prescribed burn in a windy season, in a state that's under an extreme drought warning statewide," she said. "So I think that it is likely — likely — that Congress and most of our federal partners accept that there is significant federal liability." The federal Forest Service has said it is doing a review to determine what went wrong, but they have refused to provide documents or additional details about the decision to ignite the fire. A National Weather Service forecast prepared at forestry officials' request predicted wind gusts on April 6 reaching 25 mph and humidity as low as 9%, according to records. Gonell recounted the events of that day and the impact it has had on law enforcement officers: "For most people, Jan. 6 happened for a few hours," he said. "But for those of us who were in the thick of it, it has not ended."

It was the first hearing held by the Democratic-led House select committee investigating the attack by pro-Trump rioters who were trying to stop the certification of the presidential election, which Donald Trump lost to Democrat Joe Biden. Judge Ketanji Brown Jackson's opening remarks Chairman Durbin, Ranking Member Grassley, and Distinguished Members of the Judiciary Committee: thank you for convening this hearing and for considering my nomination as Associate Justice of the Supreme Court of the United States. I am humbled and honored to be here, and I am truly grateful for the generous introductions that my former judicial colleague, Judge Tom Griffith, and my close friend Professor Lisa Fairfax have so graciously provided.

I am also very thankful for the confidence that President Biden has placed in me and for the kindness that he and the First Lady, and the Vice President and Second Gentleman, have extended to me and my family.

Today will be the fourth time that I have had the honor of appearing before this Committee to be considered for confirmation. Over the past three weeks, I have also had the honor of meeting each member of this Committee separately, and I have met with 45 Senators in total. Your careful attention to my nomination demonstrates your dedication to the crucial role that the Senate plays in this constitutional process. And I thank you. When I was born here in Washington, my parents were public school teachers, and to express both pride in their heritage and hope for the future, they gave me an African name; "Ketanji Onyika," which they were told means "lovely one." My parents taught me that, unlike the many barriers that they had had to face growing up, my path was clearer, such that if I worked hard and believed in myself, in America I could do anything or be anything I wanted to be. Like so many families in this country, they worked long hours and sacrificed to provide their children every opportunity to reach their God-given potential. My parents have been married for 54 years, and they are here with me today; I cannot possibly thank them enough for everything they've done for me. I love you, Mom and Dad.

My father, in particular, bears responsibility for my interest in the law. When I was four, we moved back to Miami so that he could be a full-time law student. We lived on the campus of the University of Miami Law School, and during those years, my mother pulled double duty, working as the sole breadwinner of our family, while also guiding and inspiring four-year-old me. My very earliest memories are of watching my father study—he had his stack of law books on the kitchen table while I sat across from him with my stack of coloring books.

My parents also instilled in me—and in my younger brother Ketajh—the importance of public across the state of the state of

service. After graduating from Howard University, Ketajh started out as a police officer, following two of our uncles. In the wake of the September 11th attacks, he volunteered for the

Army, and became an infantry officer, serving two tours of duty in the Middle East. Ketajh is here today, providing his love and support as always.

And speaking of unconditional love, I would like to introduce my husband of 25 years, Dr. Patrick Jackson. I have no doubt that, without him by my side from the very beginning of this incredible professional journey, none of this would have been possible. We met in college more than three decades ago, and since then, he has been the best husband, father, and friend I could ever imagine. Patrick, I love you.

William—Patrick's identical twin—is here as well, along with his wonderful wife Dana. Also here, from Salt Lake City, Utah, are Patrick's older brother Gardie and his wife Natalie. And my very dear in-laws—the matriarch and patriarch of the Jackson family—Pamela and Gardner Jackson—have traveled here from Boston to be with me today.

And, of course, I am saving a special moment in this introduction for my daughters, Talia and Leila. Girls, I know it has not been easy as I have tried to navigate the challenges of juggling my career and motherhood. And I fully admit that I did not always get the balance right. But I hope that you have seen that with hard work, determination, and love, it can be done. I am so looking forward to seeing what each of you chooses to do with your amazing lives in this incredible country. I love you so much.

There are so many others who are not here today, but who I need to acknowledge. I have a large extended family, on both sides; they are watching from Florida, North Carolina, New Jersey, Connecticut, New York, Massachusetts, Colorado, and beyond. I also have incredible friends—three of my college roommates came here today to support me—and I have so many other boosters, from Miami Palmetto Senior High School, Harvard undergrad, Harvard Law School, and all throughout my professional and personal life.

I have also had extraordinary mentors, like my high school debate coach, Fran Berger, may she rest in peace: she invested fully in me, including taking me to Harvard—the first I'd ever really thought of it—to enter a speech competition. Mrs. Berger believed in me, and, in turn, I believed in myself.

Remarks continued: In the category of great mentors, it is also my good fortune to have the chance to clerk for three brilliant jurists who became my professional role models: U.S. District Judge Patti Saris; U.S. Court of Appeals Judge Bruce Selya; and Supreme Court Justice Stephen Breyer.

Justice Breyer not only gave me the greatest job that any young lawyer could ever hope to have, but he also exemplifies what it means to be a Supreme Court Justice of the highest level of skill and integrity, civility, and grace. It is extremely humbling to be considered for Justice Breyer's seat, and I know that I could never fill his shoes. But if confirmed, I would hope to carry on his spirit.

On the day of his Supreme Court nomination, Justice Breyer said: "What is Law supposed to do, seen as a whole? It is supposed to allow all people -- all people -- to live together in a society, where they have so many different views, so many different needs, to live together in a way that is more harmonious, that is better, so that they can work productively together."

Members of this Committee: If I am confirmed, I commit to you that I will work productively to support and defend the Constitution and the grand experiment of American democracy that has endured over these past 246 years.

I have been a judge for nearly a decade now, and I take that responsibility and my duty to be independent very seriously. I decide cases from a neutral posture. I evaluate the facts, and I interpret and apply the law to the facts of the case before me, without fear or favor, consistent with my judicial oath.

I know that my role as a judge is a limited one—that the Constitution empowers me only to decide cases and controversies that are properly presented. And I know that my judicial role is further constrained by careful adherence to precedent.

Now, in preparing for these hearings, you may have read some of my more than 570 written decisions, and noticed that my opinions tend to be on the long side. That is because I also believe in transparency: that people should know precisely what I think and the basis for my decision. And all of my professional experiences, including my work as a public defender and a trial judge, have instilled in me the importance of having each litigant know that the judge in their case has heard them, whether or not their arguments prevail in court.

During this hearing, I hope that you will see how much I love our country and the Constitution, and the rights that make us free. I stand on the shoulders of many who have come before me, including Judge Constance Baker Motley, who was the first African American woman to be appointed to the federal bench and with whom I share a birthday. And like Judge Motley, I have dedicated my career to ensuring that the words engraved on the front of the Supreme Court building—"Equal Justice Under Law" — are a reality and not just an ideal. Thank you for this historic chance to join the highest Court, to work with brilliant colleagues, to inspire future generations, and to ensure liberty and justice for all.

And while I am on the subject of gratitude, I must also pause to reaffirm my thanks to God, for it is faith that sustains me at this moment. Even prior to today, I can honestly say that my life had been blessed beyond measure.

The first of my many blessings is the fact that I was born in this great Nation, a little over 50 years ago, in September of 1970. Congress had enacted two Civil Rights Acts in the decade before, and like so many who had experienced lawful racial segregation first-hand, my parents, Johnny and Ellery Brown, left their hometown of Miami, Florida and came to Washington D.C. to experience new freedom.

Missouri Sen. Josh Hawley distorted Jackson's sentencing record in cases related to child pornography, painting her as sympathetic to offenders. His line of questioning tied into conspiracy theories that have been debunked by experts. The White House called his rhetoric a "embarrassing QAnon-signaling smear." Jackson pushed back at his claims, noting that judges have to determine how to sentence defendants consistent with the requirements that Congress has set forward. "Sentencing is a discretionary act of a judge, but it's not a numbers game," she said. Judge Ketanji Brown Jackson faced another day of questions during her confirmation hearing for the U.S. Supreme Court. And things got a little heated today, so we'll warn you that there may be some profanity ahead in the conversation we're about to have with NPR legal affairs correspondent Nina Totenberg and senior political editor and correspondent Domenico Montanaro. Good to have you both here.

DOMENICO MONTANARO, BYLINE: Thanks for having us. NINA TOTENBERG, BYLINE: Nice to be here.

SHAPIRO: Before we get to today's hearing, Nina, could you just briefly bring us up to speed on Justice Clarence Thomas, who has been hospitalized since last Friday night?

TOTENBERG: Well, we really don't know anything more than we were told initially. He has an infection and is being treated with intravenous drugs. But initially, the court's press office said that he was expected to be discharged on Monday or Tuesday. And now it's Wednesday, so he's been there five days, suggesting that perhaps there's something fairly serious going on. And that underlines the importance of these hearings.

SHAPIRO: And let's talk about what happened at these hearings today. Judge Jackson's sentencing record for child pornography cases once again became a focal point of questions from some Republican senators.

TOTENBERG: That's exactly right. Judge Jackson again got hammered over a handful of child pornography cases in which she sentenced defendants to less time than recommended by prosecutors or that would have been required under the sentencing guidelines or were at the low end. Now, this record, we should note, is the same as some 70 to 80% of other judges. And that's because when the law was written in 2003, almost all pornography was traded by mail. And one of the sentencing enhancements was based on the amount of pornography purchased or distributed by mail. Today, of course, on the internet - and that's how everybody does this - one click can transmit thousands of images. So most judges don't necessarily consider one or two or three clicks as an aggravating factor. But some Republicans see things differently, like Lindsey Graham. NPR does not have advance details of what will be in these videos. However, past video has been full of depictions of the attack itself; including violent clashes, loud noises, shouting and profane language. NPR hosts and correspondents will advise listeners of the content of these recordings ahead of and during playback, and will verbally describe what is being seen on screen. NPR will not silence or bleep the playback of these recordings, as they are a part of the historic record in this Congressional hearing.

Writing for the court majority, Justice Samuel Alito said that the 1973 Roe ruling and repeated subsequent high court decisions reaffirming Roe "must be overruled" because they were "egregiously wrong," the arguments "exceptionally weak" and so "damaging" that they amounted to "an abuse of judicial authority."

The decision, most of which was leaked in early May, means that abortion rights will be rolled back in nearly half of the states immediately, with more restrictions likely to follow. For all practical purposes, abortion will not be available in large swaths of the country. The decision may well mean too that the court itself, as well as the abortion question, will become a focal point in the upcoming fall elections and in the fall and thereafter. KANW provides 156 hours of Native American music annually, connecting rural and underserved populations to their history and heritage.

KANW works with the New Mexico Secretary of State's office, Bernalillo County Clerk's office, Sandoval County Clerk's office and Public School districts to provide native language translations of election information announcements for federal, state, county, city and school elections. Native Languages include Keres, Navajo, Tewa, and Towa.

KANW is a sponsor for New Mexico Latin Music Association Awards, Los 15 Grandes De Nuevo Mexico Awards, and the New Mexico Hispano Music Association, Hispano Music Awards; programs rewarding music excellence in the Hispanic community.
