Maine Public's revenues come from voluntary contributions from over 51,000 individual supporters, as well as underwriting support from businesses and nonprofit organizations. Additional funding is received through an annual appropriation from the State of Maine and from television and radio community service grants from the Corporation for Public Broadcasting.
