# Count 1

The defendant, on an occasion on or about September 2013, in Suffolk County, being twenty-one years old or more, did engage in sexual intercourse with Jane Doe, a person known to the Grand Jury, who was less than seventeen years old.

### Count 2

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, TIMOTHY J. HARRISON, of the crime of CRIMINAL SEXUAL ACT IN THE THIRD DEGREE, in violation of section 130.40(2) of the Penal Law of the State of New York, committed as follows:

The defendant, on an occasion on or about September 2013, in Suffolk County, being twenty-one years old or more, did engage in oral sexual conduct with Jane Doe, a person known to the Grand jury, who was less than seventeen years old.

### Count 3

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, TIMOTHY J. HARRISON, of the crime of RAPE IN THE THIRD DEGREE, in violation of section 130.25(2) of the Penal Law of the State of New York, committed as follows:

The defendant, on or about an occasion occurring in October/November 2013, in Suffolk County, being twenty-one years old or more, did engage in sexual intercourse with Jane Doe, a person known to the Grand Jury, who was less than seventeen years old.

# Count 4

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, TIMOTHY J. HARRISON, of the crime of CRIMINAL SEXUAL ACT IN THE THIRD DEGREE, in violation of section 130.40(2) of the Penal Law of the State of New York, committed as follows:

The defendant, on or about an occasion occurring in October/November 2013, in Suffolk County, being twenty-one years old or more, did engage in oral sexual conduct with Jane Doe, a person known to the Grand Jury, who was less than seventeen years old.

# Count 5

THE GRAND JURY OF SUFFOLK COUNTY, by this Indictment, accuses the defendant, TIMOTHY J. HARRISON, of the crime of ENDANGERING THE WELFARE OF A CHILD, in violation of section 260.10(1) of the Penal Law of the State of New York, committed as follows:

The defendant, on or about and between September 2013 and November 2013, in Suffolk County, knowingly acted in a manner likely to be injurious to the physical, mental or moral welfare of Jane Doe, a child less than seventeen years old, whose identity is known to the Grand Jury.
