COUNT 7: THREATENING OR INTIMIDATING, A CLASS 1 MISDEMEANOR (Antonio Luis Felix and Luis Ricardo Vasquez Jr)

COUNT 8: TAMPERING WITH PHYSICAL EVIDENCE, A CLASS 6 FELONY (Antonio Luis Felix and Luis Ricardo Vasquez Jr)

COUNT 9: CONSPIRACY TO COMMIT HINDERING PROSECUTION IN THE FIRST DEGREE, A CLASS 5 FELONY (Antonio Luis Felix and Luis Ricardo Vasquez Jr)

The Grand Jurors of Maricopa County, Arizona, accuse ANTONIO LUIS FELIX, LUIS RICARDO VASQUEZ JR, on August 31, 2026, charging that in Maricopa County, Arizona:

COUNT 1:

ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, knowingly did restrain Andrea Caperlac with the intent to inflict death, physical injury, or a sexual offense on her or to otherwise aid in the commission of a felony, in violation of A.R.S. §§ 13-1304, 13-1301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

COUNT 2:

ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, knowingly did restrain Jesus David Diez with the intent to inflict death, physical injury, or a sexual offense on him or to otherwise aid in the commission of a felony, in

violation of A.R.S. §§ 13-1304, 13-1301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a gun, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 3:

LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, using a gun, a deadly weapon or dangerous instrument, intentionally did place Jesus David Diez in reasonable apprehension of imminent physical injury, in violation of A.R.S. §§ 13-1203, 13-1204, 13-3105, 13-701, 13-702, and 13-801.

The State further alleges that the offense charged in this count is a dangerous felony because the offense involved the discharge, use, or threatening exhibition of a gun, a deadly weapon or dangerous instrument, in violation of A.R.S. §§ 13-105 and 13-704.

COUNT 4:

ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, intentionally, knowingly or recklessly did cause physical injury to Jesus David Diez, while his capacity to resist was substantially impaired, in violation of A.R.S. §§ 13-1203, 13-1204, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

COUNT 5:

ANTONIO LUIS FELIX, on or about August 5, 2026, intentionally, knowingly or recklessly did cause physical injury to Andrea Caperlac, while her capacity to resist was substantially impaired, in violation of A.R.S. §§ 13-1203, 13-1204, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

COUNT 6:

LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, recklessly did deface or damage property, to-wit: driver's side window, of Jesus David Diez and/or Rebecca Vilchis, causing damage in an amount of more than \$250 but less than \$1,000, in violation of A.R.S. §§ 13-1602, 13-1601, 13-707, and 13-802.

COUNT 7:

ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, threatened or intimidated by word or conduct to cause physical injury to Andrea Caperlac and/or Jesus David Diez, or to cause serious damage to the property of Andrea Caperlac, in violation of A.R.S. §§ 13-1202, 13-301, 13-302, 13-303, 13-304, 13-707, and 13-802.

COUNT 8:

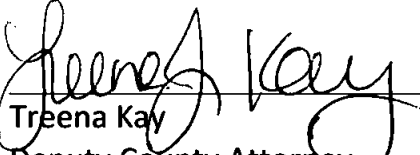
ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, with intent that it be used, introduced, rejected or made unavailable in an official proceeding which was then pending or which ANTONIO LUIS FELIX AND LUIS RICARDO

VASQUEZ JR knew was about to be instituted, did destroy, mutilate, alter, conceal or remove physical evidence, to-wit: cell phone, with the intent to impair its verity or availability, in violation of A.R.S. §§ 13-2809, 13-2801, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801.

COUNT 9:

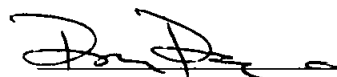
ANTONIO LUIS FELIX AND LUIS RICARDO VASQUEZ JR, on or about August 5, 2026, with the intent to promote or aid the commission of an offense, to-wit: kidnapping and/or aggravated assault and/or threatening or intimidating, agreed with Luis Ricardo Vasquez Jr and/or Antonio Luis Felix that at least one of them or another would engage in conduct constituting the offense of kidnapping and/or aggravated assault and/or threatening or intimidating, and Luis Ricardo Vasquez Jr and/or Antonio Luis Felix, committed the following overt act(s): using intermittent patrol vehicle lights to stop the 2014 Dodge Charger, license plate ZHA70R, and/or striking the rear bumper of the 2014 Dodge Charger, license plate ZHA70R, with their patrol vehicle in violation of A.R.S. §§ 13-1003, 13-2510, 13-2512, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801
