18. Synopsis:

- On May 16, 2025, at approximately 4:44 PM, L.S. responded to the Nashua Police Department to file a report in regards to a sexually explicit photograph of her being posted to the social media application Reddit without her permission. Officer Annika Stone spoke with L.S. who stated three photographs of her in which her bare breasts are exposed were posted to the social media application Reddit.
- Reddit can be described as; Reddit consists of online communities known as "subreddits" or "subs" organized around the shared interests of their members. Each subreddit has its own page, subject matter, users, and volunteer moderators (also known as "mods"). Community members interact within these subreddits by posting topical information, articles, stories, links, news, images, and videos, which are then voted and commented upon by Reddit account holders. The number of upvotes and downvotes a post receives helps determine its position within the subreddit.
- Detectives with the Special Investigations Division were assigned to further this investigation. Detective Brendan Whalen conducted a formal interview with L.S. on May 21, 2025. L.S. stated she met Bryan Morse via Facebook sometime at the beginning of April 2025. L.S. stated she met Bryan one time in person between May 5, 2025, and May 11, 2025. According to L.S., Bryan picked her up from her residence and they went to Mines Falls Park in Nashua, New Hampshire.
- Once at the park L.S. and Bryan walked around for several hours conversing about their lives. Bryan and L.S. then left the park, in Bryan's vehicle, and Bryan parked his vehicle on a street in close proximity to Mines Falls. L.S. stated she then gave Bryan a "blow-job," meaning oral sex, while within Bryan's vehicle. Bryan then drove L.S. back to her residence.

- L.S. stated while she was with Bryan, he was speaking about his responsibilities as a State Representative and his voting habits. According to L.S., she then became curious about Bryan and Googled Bryan's name. L.S. stated she then discovered Bryan is married. According to L.S. this upset her as she did not want to be in a relationship with Bryan as he was married.
- Prior to meeting Bryan in person L.S. and Bryan had conversed with one another via text message and the social media application Snapchat. L.S. stated during her conversations with Bryan, she had sent Bryan three photographs of herself. L.S. stated these photographs were of her bare breasts, with two of the photos showing her face. L.S. also stated Bryan had sent her photographs of his erect penis.
- According to L.S. between Monday, May 12, 2025, and Thursday, May 15, 2025, she had messaged Bryan's wife on Facebook messenger. L.S. stated she wanted to tell Bryan's wife about Bryan's infidelity. L.S. never received a response to her message on Facebook.
- On Friday, May 16, 2025, at approximately 6:34 AM, Bryan sent L.S. two of the photographs she had originally sent him. These photographs depicted L.S.' bare breasts as well as her face. L.S. stated Bryan then called her at approximately 6:35 AM, and was angry with her for messaging his wife and stated L.S. had no right to discuss anything with his wife. Bryan stated he would "tell the world" about L.S. As Bryan was yelling and swearing at L.S., she ended the phone call after a few minutes.
- On May 16, 2025, at approximately 3:20 PM, L.S. received a message from an ex-boyfriend informing her there were sexually explicit photographs of her on Reddit. L.S.' ex-boyfriend then sent the post from Reddit to L.S. The post was from the username "BusinessMurky9719." There were two separate posts. One under the subreddit "NHSwingers" with the title being "Enjoy [REDACTED] from Nashua." The second post being under the subreddit "Busty Naturals," with the title being "Enjoy [REDACTED] from Nashua." The posts contained two separate images, which were blurred as L.S. does not have an account with Redit, however they clearly depicted a woman showing her breasts. L.S. was able to Google "L.S. Nashua, NH XXX Reddit" and discovered the two photographs which had been posted by "BusinessMurky9719" were the same photographs she had sent Bryan.
- Detective Whalen viewed the photographs from Google, which had been posted to Reddit, and was able to confirm the photographs were of L.S. Both of the photographs were also the same photographs Bryan had sent to L.S. and the photographs showed L.S.' face and bare breasts.
- Detective Whalen viewed the photographs which had been posted to Reddit and was able to confirm the photographs were of L.S. as her face was visible in the photographs. Detective Whalen confirmed the two photographs which were posted to Reddit were the same photographs Bryan had sent to L.S. on May 16, 2025. L.S. stated she has only sent these photographs to Bryan. L.S. stated she did not give Bryan consent to post these photographs and they were posted without her knowledge.
- Once L.S. had been made aware of the photographs being posted to Reddit, she called Bryan to confront him. Bryan did not immediately answer L.S., however he eventually answered L.S. Once Bryan answered the phone L.S. confronted him about the photographs being posted to Reddit as they were the same photographs he had sent to her earlier in the day. Bryan denied posting the photographs and informed L.S., he did not know what she was talking about. According to L.S., Bryan then stated something to the effect of "you cannot trace it." Bryan then ended the phone call with L.S.
- According to L.S., she was angry with Bryan so she went onto her Facebook account and posted "Shout out to Bryan Morse – NH State Representative, Franklin, for posting naked photos of someone online when he gets caught cheating on his wife. Quite the catch to have in office." L.S. stated she "tagged" Bryan's Facebook account in the post, meaning Bryan and other individuals would be able to see what she had posted. L.S. then received four missed phone calls from a blocked phone number.
- L.S. stated she then received the following voicemail from Bryan; "So I see what you did where you decided to try and post me up on Facebook with labeling information. Just so you know interfering with an elected official, especially if they represent a state representative or a senator in the State of New Hampshire is a Class A Felony. So, I suggest taking it down and we just part our damn ways because I can pursue legal action that will put you behind bars

for years. So, this is your official cease and desist. Cut the shirt and leave me the fuck alone or I will be pursuing you for legal action goodbye. Oh yeah and I have the proof. I have a screenshot from an individual on your little Facebook page that sent it to me so I have it with your name, your profile picture and everything. There's a huge difference from what you claimed versus what I fucking have. Class A Felony. Last chance to take it down part our god damn ways or you will be arrested by the end of next week. Goodbye."

- During the interview with L.S., Detective Whalen asked L.S. for consent to have her phone examined by the Computer Forensics Unit. L.S. provided written consent for her phone to be examined.
- The photographs of L.S. which were posted on Reddit have since been removed as the account holder for the username "BusinessMurky9719" deleted the posts as well as their Reddit account. Detective Whalen completed a preservation request for the Reddit account "BusinessMurky9719." The preservation request was accepted and stated the account information would be preserved for ninety days.
- On May 30, 2025, Detective Whalen reviewed the extraction report for L.S.'s phone. While reviewing the extraction report Detective Whalen was able to view text messages between Bryan and L.S. On May 12, 2025 Bryan texted [REDACTED] "Maybe we can get together and I can get another slurpin turf 20,000." L.S. did not respond to this message.
- Detective Whalen then observed a text from Bryan to L.S. which contained two photographs. The photographs were of L.S. in which L.S.' bare breasts are exposed and her face is visible. Bryan then calls L.S. three times and on the third call, May 16, 2025, at 6:34 AM, L.S. answers Bryan. L.S. then calls Bryan six times on May 16, 2025 between 3:05 PM and 3:06 PM. All of the calls to Bryan were not answered. L.S. then texts Bryan at approximately 3:05 PM, stating "I will come after you in court." Bryan does not answer this text message.
- On June 12, 2025, Detective Whalen completed a search warrant to Reddit which was signed into effect by the Honorable Judge Michael Klass, which was then sent to Reddit.
- On June 13, 2025, Detectives Whalen and Nicholas Markarian responded to [REDACTED], Franklin, New Hampshire in an attempt to speak with Bryan. Bryan was not home and informed Detective Whalen he was unable to respond home. Detective Whalen asked Bryan if he would be willing to speak over the phone, which he consented to.
- Bryan stated he knew why Detectives were looking to speak with him and admitted to meeting L.S. on Facebook. Bryan reported knowing about the post L.S. had made on Facebook about him and Bryan stated he never posted L.S.' nude photographs online. In L.S.' Facebook post she did not say Bryan had posted her nude photographs only that Bryan had posted "naked photos of someone."
- Bryan admitted to L.S. sending him well over twenty nude photographs, specifically of her bare breasts. Bryan reported he could not remember if he ever sent L.S. any photographs despite L.S. reporting Bryan had sent her multiple photographs of his erect penis.
- Detective Whalen then asked Bryan if there was ever any physical contact, to include hugging, kissing, or any sexual contact, between him and L.S. Bryan stated there was never any physical contact between him and L.S. despite L.S. reporting she had given Bryan oral sex with then met in May of 2025. When Detective Whalen reviewed L.S.' phone extraction he was able to observe a text message from Bryan to L.S. on May 12, 2025, which stated "Maybe we can get together and I can get another slurpin turf 20,000; p."
- Detective Whalen was unable to ask Bryan about this text message as Bryan stated something to the effect of "I normally do not talk with the Police without my lawyer being present." Detective Whalen asked if Bryan wished to conclude the conversation. Bryan stated he did not have an issue speaking with the Police, however he typically prefers to have his lawyer present. At this time Detective Whalen concluded the conversation with Bryan.
- On June 24, 2025, Detective Whalen received the results from the Reddit search warrant. Detective Whalen then reviewed the report from the search warrant. The report indicated the Reddit account "BusinessMurky9719" was created on 11/29/2022 and was then deleted on 05/16/2025, which is the day L.S. made her report to the Nashua Police Department as she discovered her photographs had been posted to Reddit. The report stated the email address [REDACTED] was used to create the "BusinessMurky9719" Reddit account.

- While reviewing the report from Reddit, Detective Whalen was able to see the posts which were made by the account "BusinessMurky9719" on May 16, 2025. There were two posts made by the account "BusinessMyrky9719," which contained the name [REDACTED]. The first post was made under the Subreddit "NHSwingers" with the title being "[REDACTED] from Nashua." This photograph showed L.S.' bare breasts as well as her face. The second post from May 16, 2025, was under the Subreddit "BustyNaturals" with the title being "Enjoy [REDACTED] from Nashua." This photograph also showed L.S.' bare breasts and her face. The link to both of these pots indicated the post had since been deleted by the user/original poster.
- When Detective Whalen originally spoke with L.S., these were the exact same posts she had shown Detective Whalen. When Detective Whalen originally viewed the posts they both contained photographs of L.S. with her face being visible as well as her bare breasts being exposed.
- Within the report from Reddit was Internet Protocol (IP) addresses which were used by the "BusinessMurky9719" account. One of the IP addresses was an IPv4 address of 24.233.218.162. There was an additional IPv6 address of 2607:fb91:d77:46f3:ecc4:64b1:e3f3:8939.
- Using the American Registry for Internet Numbers (ARIN) Detective Whalen queried the IPv4 address of 24.233.218.162. The query indicated the IPv4 address was registered to Breezline Internet. Detective Whalen also queried the IPv6 address of 2607:fb91:d77:46f3:ecc4:64b1:e3f3:8939. The query indicated this IPv6 address belonged to T-Mobile. Detective Whalen then completed search warrants for both Breezline Internet and T-Mobile.
- On July 9, 2025, Detective Whalen received the results from the search warrant which had been submitted to Breezline Internet. Breezline Internet responded stating IP address 24.233.218.162 belonged to Bryan Morse, with a listed address of [REDACTED], Franklin, New Hampshire. This was the same address Detective Whalen responded to on June 13, 2025, in an attempt to speak with Bryan.
- On September 5, 2025, Detective Whalen submitted a search warrant to T-Mobile for the IPv6 address 2607:fb91:d77:46f3:ecc4:64b1:e3f3:8939. T-Mobile responded to this search warrant on September 17, 2025, stating the data for IPv6 addresses was only kept for ninety days and the data which Detective Whalen had requested was no longer available.
- On October 29, 2025, at approximately 5:22 PM, Detectives Michael Casey and Whalen responded to [REDACTED], Franklin, New Hampshire in an attempt to speak with Bryan. Detective Whalen knocked on the door and Bryan came to the door looked at Detectives and then retreated back into the residence. Detective Whalen knocked several more times, however Bryan refused to answer the door.
- Detective Whalen then called Bryan who refused to answer the phone call. Detective Whalen texted Bryan asking if Bryan would be willing to step outside and speak. Bryan did not answer the text message until much later. Bryan provided the name, phone number, and address of his lawyer and stated Detective Whalen would need to contact his lawyer for any further communication.
- On November 4, 2025, Detective Whalen completed a search warrant to Google for the Google email address [REDACTED]. This was the email address which had been used to create the Reddit account "BusinessMurky9719." The warrant was then signed into effect by the Honorable Judge Jonathan Frizzle.
- On November 10, 2025, Detective Whalen received the results from the search warrant which had been submitted to Google. One section of the search warrant report was titled Google Pay Customer Information. Within this section was contact information for the account holder. The account holder was listed as Bryan Morse with a listed address of [REDACTED], Franklin. This being the same address Detective Whalen had responded to in the past in an attempt to speak with Bryan.
- Also within the search warrant report was a section titled Google Subscriber information. Within this section there was a recovery email address of [REDACTED] listed. There was also a phone number of [REDACTED] listed. This is the same phone number Detective Whalen had called when he spoke with Bryan as well as communicating with Bryan through text messaging.

- On November 13, 2025, Detective Whalen completed an arrest warrant for Bryan, charging him with one count of Nonconsensual Dissemination of Private Sex Images. On November 14, 2025, the Honorable Judge William Delker reviewed and signed the arrest warrant into effect.
- On November 20, 2025, Bryan responded to the Nashua Police Department to turn himself in. Officer Kyle Crosson made contact with Bryan and placed him under arrest. Detective Whalen later responded to the detention area of the Police Department to make contact with Bryan. Bryan stated he was not willing to speak without his lawyer present.
- As a result of this investigation Bryan was charged with the following offenses:
- Nonconsensual Dissemination of Private Sex Images for posting two photographs of L.S. on Reddit which depicted her bare breasts while her face was visible in the photographs.
