Hope you are well. Just a heads up that we are on the agenda for the City Council meeting next week.

Please see attached the document which I sent to Joshua Smith / Darren which I should make up the basis of the discussion.

The key benefits are:

1. ANTICIPATED BENEFITS OF THE SALE
The anticipated benefits of the sale may include

- a. Construction value of \$1.5 billion per 100 MW of power supplied to the site;
- b. Power Purchase Agreement worth \$200 million per annum;
- c. 300-500 skilled on-site jobs during development and operations;
- d. 500-1,000 associated and supply chain jobs;
- e. Significant economic stimulus to the City, including increased economic activity, employment, and tax revenue;
- f. Increased tax income for the City, both from the data center and residential development;
- g. Infrastructure and facilities upgrades to accommodate the data center and residential development;
- h. Real estate development opportunities as a result of the increased demand for housing and commercial space;
- i. Potential to create a regional tech hub, attracting further investment and economic growth.

2. CONSTRUCTION OF AFFORDABLE HOMES AT COST

In the event of an onward sale or transfer of the land or development rights by Huntley, Huntley agrees to construct 100 homes for the City at cost only (including reasonable allowance for overhead) but without profit, on land provided by the City for \$1 / acre within the residential development portion of the project. The construction of these homes shall be completed within a reasonable timeline, to be mutually agreed upon by both parties, and the City will have the right to review and approve the construction plans. The City agrees to provide Huntley with the necessary support and approvals to ensure the timely completion of these homes.

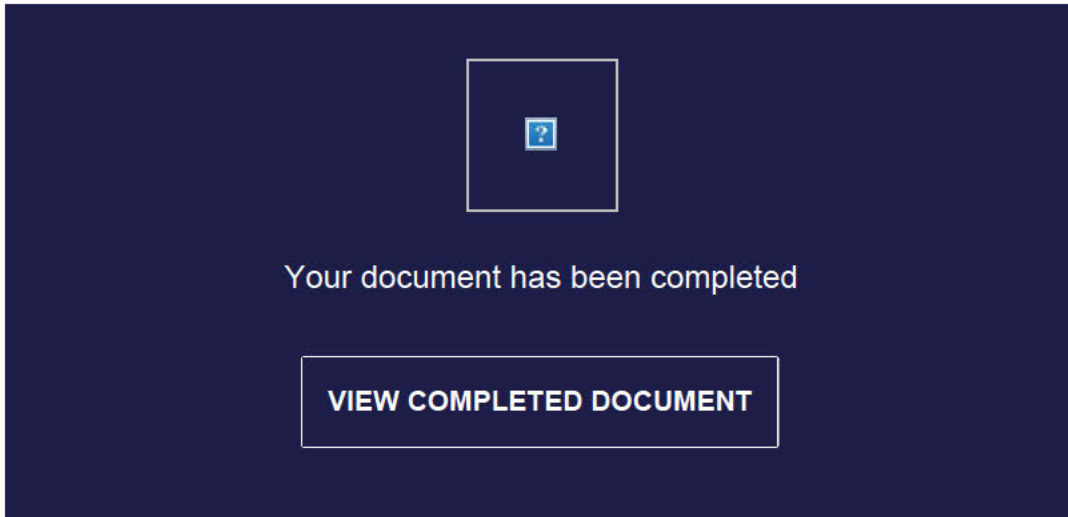

Hi Darren

Completely understand.

How about reducing the land portion to an area that can accommodate approximately 500 units, focusing on multi-family or duplex-style housing? We can consult with Zach on a reasonable size, but I'd suggest planning for around 8 units per acre, meaning a total of 70 - 100 acres. This would allow for well-designed amenities with access from Sandhill Road.

Unfortunately, workforce housing wouldn't be viable in Indigo/Potato Hill, and the zoning there does not permit multi-family development. However, this project could significantly enhance the feasibility of residential development in Indigo Ridge and across the City. We see the data center project as a key catalyst for residential growth there and for broader development across the City.

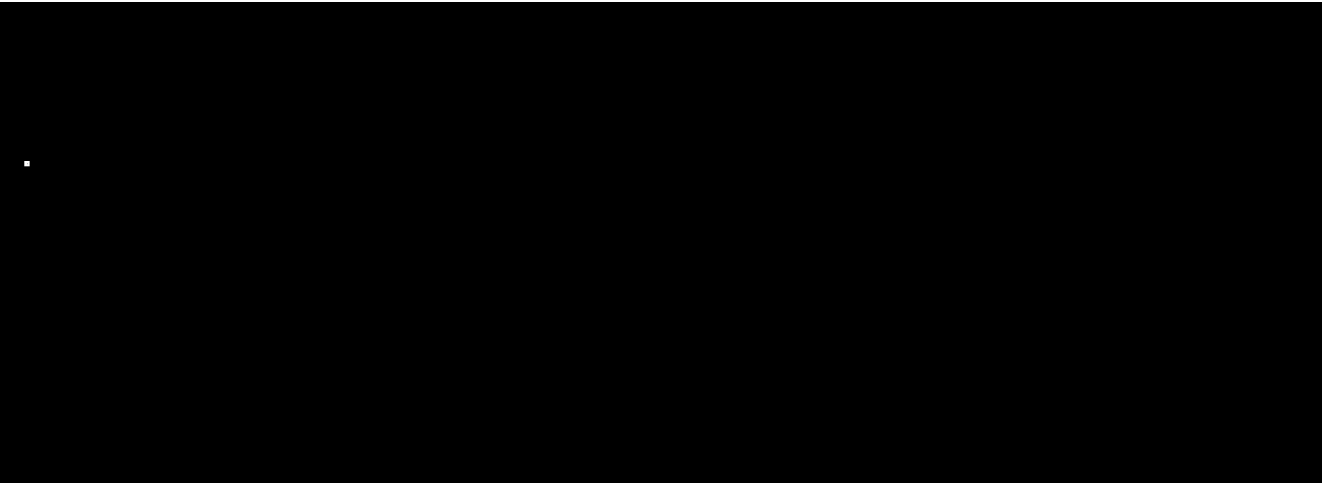
Well done last night. I think that presentation was very helpful. I was also surprised that there wasn't a few dissenting voices from the public. I think that is a very good sign for your project.

Keith,

Attached is what I believe should be close to the final version of the agreement. I made small edits to 1(e) and paragraph 4. I also added a provision (10(g)) as you requested for assignment. The only other issue was the termination notice. You indicated that 10 days was too short. Is 60 ok?

I believe I understand what the intent of Huntley is with respect to the agreement. But just so that there is no confusion, we will do our best to keep information confidential but ultimately we cannot contract around the law or the requirements that the law imposes on a municipality when it comes to sharing information. Arizona law does afford some protection for confidential information, but the definition of "Confidential Information" in the agreement exceeds the scope of what the law protects. In the event that the law conflicts with the agreement, the law will control.

For example, the law would generally protect proprietary information in reports that is developed by you as part of your due diligence, but it would not protect records that indicate your general proposed use for the land. In the event of a records request to the city, we may have to disclose information that you would not want us to disclose but we would follow the procedure in paragraph 4 and allow you an opportunity to seek a court order protecting the information that you believe is confidential pursuant to law.

Once we get all of the last details hammered out, Darren will follow up with you by phone on execution of the agreement.




Thank you for your time yesterday. We have had initial discussions with some potential providers, and I wanted to share the key highlights of our proposal for your review:

1. **Preferred Site:** A 500-acre site, for which we are willing to pay industrial market value.
2. **Buildings:** Approximately 15 buildings, each around 30 acres in size (approximately 30 feet high).
3. **Job Creation:** Anticipated creation of around 500 long term jobs for the city, plus additional jobs in the supply chain and during construction.
4. **Construction Value:** Estimated \$2 billion in construction work, with associated job creation and tax revenue.
5. **Residential Development:** We seek land zoned for townhomes, apartments, or condos, to construct approximately 500 homes at market rate.
6. **Power Agreement:** A 25-year power agreement with the City, with an estimated annual spend of \$150 million.

We would like to proceed with an NDA and Exclusivity Agreement for a 12-month period to explore this opportunity further, based on the following framework:

- A. **Option to Purchase Land:** Hollybrook will have the option to purchase land at market value (average of three valuations) for its current use (either industrial or residential).
- B. **Power Contract:** The City will retain sole benefit of the power contract.
- C. **Tax Revenues:** The City will retain the sole benefit of any taxes generated.
- D. **Affordable Housing Commitment:** Hollybrook will build 20% of all new homes (approximately 100 homes) at actual cost for affordable housing within the city.
- E. **Commercial Space Development:** Hollybrook will collaborate with the City to develop some commercial space to support the Data Centre.
- F. **Land Entitlements:** Hollybrook will prepare the planning and technical documentation to obtain the necessary entitlements for Data Centre development.
- G. **Land Sale Agreement:** Hollybrook will handle sourcing and brokering the land sale agreement.
- H. **Land Value Uplift:** Any increase in existing land value to sale value will be split 70/30 in Hollybrook's favor.

This is a high-level overview, but given its sensitivity, we are eager to finalize the NDA and Exclusivity Agreement before Christmas, if possible.
