Call to order

Review and approve previous meeting minutes:

Approve July Minutes: seconded by Caleb

Update from Megan:

- Welcome to Tracy. Tracy will be tracking grants and updating the process for contacting members both new and old
- CPB has been submitted and accepted. (Way to go Megan!!)
- Income was overstated in 2021 and we have a small deduction from our grant next year
- We successfully closed the Bingo Account
- Reese Henry is going to submit the letter required by the IRS
- KDNK has a new partnership with Iron Mountain Hot Springs traded underwriting for passes

Finance Committee Updates

- Bob analyzed Member levels and it looks like KDNK is in line with where we should be

Building Updates

- Water got in and created water damage that needs to be addressed.
- We have a quote for the work that is left. Megan and her husband have been able to knock out a lot of the work. The quote for fixing the septic system warrants a second quote. The problem is with the septic system.
- Helpers will test for asbestos and mold inspections. The station may need to get quotes based on that inspection. Worth seeing if there are resources for free for inspections.
- This is all separate from the drywall a floor fix that needs to happen.
- Aimee Yllanes has some vinyl flooring to donate that we ought to be able to match.
- The station needs to prioritize the order to make sure nothing new gets damaged but Aimee has an office ASAP. *We might also need to consider whether and when the ground freezes
- Due to the age of the building, we might need to look into mold and asbestos issues.

- AZYEP is an important partnership with the station and we need to make sure it's a safe and inviting workplace
- The roof above the production and on-air studios are getting fixed on trade

Questions for the Board: How are we going to prepare for capital improvements in the future?

HR Committee Updates

- Megan has questions regarding what is sustainable with her current workload. She is putting in approximately 37 51 hours per week.
- Megan has mentioned that the board should continue to look into hiring a formal station manager.
- Per Raleigh, the board can pursue opportunities to lighten the station manager workload. Additionally, the board can begin a campaign to solicit donations.
- The burst pipes pose a health hazard and need to be addressed urgently. **ACTION**: Pay 30k to repair the pipes. AZYEP should be asked about contributing to paying for the pipes. Motioned by Eloisa. Seconded by Jonathan. UNANIMOUS.
- This presents an opportunity to see if a kitchen sink can be installed while repairs are being carried out on the pipes.
- Diego may be able to be contacted about tearing up the carpet. Volunteers can also be contacted to assist in removing the carpet.

Events Updates

- Bingo September 21st
 - Aimee Yllanes has some to donate that we ought to be able to match.
 - One other event that I missed

HR

- The news director will be off next week and we'll have an update in a week or so
- Still need to define Tracy's pay structure. Historically, this has been check written as opposed to an invoice sent
- Is KDNK paying for Salesforce? Not unless it is an additional consulting fee. Jonathan will help with training.
- KDNK should also consider rejoining [Acronym Kara mentioned]
- Motion to pay Aly the commission that was approved, which was \$955
- This is an arrangement Aly would like to maintain, however, the board is considering it. One solution could be sunsetting Aly's commission through the end of the year.
- John motions Aly receive a continuation of 10% commission through the end of the vear, and
 - Eloisa seconds, all in favor.

Megan's suggestion is that we take a good look at the structure of the station and we have defined positions with clear expectations.

Job Description - still need to determine the mix of Executive Director and General Manager. This will lean much more to a GM-style job with Tracy working more on the FR side. Kara is going to lead the process of honing this in and the next steps.
