Officer Pritzkai attempted to disperse the crowd and observed a white male with a red beard and bald head, wearing a black shirt and a black male with dark long hair, wearing a white shirt, whom was later identified as Sean Sims (Sims), screaming in each others face. Sims stated he was pepper sprayed in the face, and he threw himself toward the ground, screaming in pain. Other civilians on the scene helped move Sims off the roadway to keep vehicle traffic flowing. While moving Sims, Sims was holding a can of spray paint. EMS responded and Sims was transported to the hospital. Sims stated his skin was burning and his head hurt from someone hitting him.

On 09/15/2025, I made contact with Sims via phone call. Sims provided me a video of the event. I reviewed the video. In the video I observed Sims walk up to the bridge. He doesn't say anything to anyone. Sims starts to spray paint the graffiti bridge. A white male holding a sign and flag swats at Sims. Sims begins to tell the unknown male to stop touching him. Sims starts backing up, and saying "Woah Woah, don't touch me".

Another different male is seen charging at Sims in an aggressive manner. The male attempts to strike Sims. Sims is continously backing up. Sims raises his spray paint can ,and sprays towards the male who is charging towards him. The male is then seen removing a can from his right pocket and pointing it at Sims.

The phone drops to the ground and the video stops. Sims stated when the phone fell, he was tackeled to the ground by a third unknown male. Sims said he was hit in the head and also kicked before people started separating the suspects from him.

On 09/15/2025, an anonymous crime tip was recieved. "Attached is an screen shot of one of the individual, Wayne Hopkins, confessing to assaulting the male painting over the Charlie Kirk memorial". The tipster provided a screen shot from Wayne Hopkins' Facebook page.

The facebook post said:

"Proud to be a part of this tonight! To the guy that ran up & painted on Charlie's mural... I hope when I knocked you out with my elbow across the back of your neck when you were beinga a coward &running away felt good. I'm glad you left in an ambulance tonight. The way you cried victim was exactly what I expected you to do. You are human trash & I'm glad the police had to come pick you off the ground when I knocked you out. To the guy that pepper sprayed you on the ground... Kudos sir! I will never sit back &let something like that happen. You deserved what you got! If anybody happens to see video of this please send it to me so I can smile."

The post was made from a Facebook Account located at https://facebook.com/wayne.hopkins.52. I identified the Facebook page as, Larry Wayne Hopkins II. I located his phone number through law enforcement databases. I called Hopkins, and the phone conversation was recorded. Hopkins acknowledged he was at the Graffiti Bridge on 09/14/2025. I asked Hopkins to describe to me what

happened from his perspective. Hopkins stated he saw a black male spray paint the mural. Hopkins described that an unknown white male was chasing the black male. Hopkins said the black male was running away backwards and ran into him.

I asked Hopkins if the black male ever threatened him. Hopkins said no. I asked if the black male ever sprayed his spray paint at him. Hopkins said no. I clarified that Hopkins' first name is Larry but he goes by Wayne.

I asked Hopkins if he was aware that people were taking screen shots of his facebook posts and provided the posts to law enforcement. Hopkins acknowledged the facebook post, but again said he struck him in self defense. I read "I hope when I knocked you out with my elbrow across the back of your neck" to Hopkins and asked how that was self defense. Hopkins said becuase while the male was running backwards he ran into me. I explained to Hopkins that is not a reason to elbow strike someone and not self defense.

Through law enforcement resources, I identified the white male who pepper sprayed Sims as Troy Grow. Troy Grow made several posts about the event on his facebook page. I called Grow and conducted an interview. The interview was recorded. Grow stated right before the vigil started and unknown male spray painted the mural. Grow stated him and several other men grabbed the male and pulled him off of the mural. Grow stated the male then sprayed him with gold spray paint. While Sims was spraying Grow with spray paint, an unknown white male tackeled Sims to the ground. Grow then explained someone sprayed pepper spray. Initially Grow denied spraying pepper spray. I advised Grow, the male was recording everything. Grow then admitted to spraying Sims with pepper spray. I asked what type of pepper spray it was. Grow said "the type you buy from the store". Grow explained he always keeps pepper spray on him. Grow explained he was upset that Sims spray painted the Graffiti Bridge and thought Sims' actions were disrespectful.

On 09/16/2025, a photo line up was conducted with Sims. Detective Martinez presented the photo line up to Sims. Sims positively identified Grow as the person who tried to punch him and sprayed him with pepper spray.

Based on all statements, video footage, and circumstances, the evidence shows Grow and Hopkins battered Sims. I reviewed Grow's criminal history. Grow was convicted of battery on 02/03/1995, and 06/27/2013. I reviewed Hopkins' criminal history. Hopkins was convicted of battery on 04/16/1997, and 10/01/2001. Based on both having two prior battery convictions, the evidence shows they violated F.S.S. 784.03.2, Felony Battery.
