LAUNCHED IN 2007, THE STATION PROVIDES REGIONAL AND NATIONAL EXPOSURE TO MILWAUKEE'S COMMUNITY ASSETS, MUSICIANS, NON-PROFIT ORGANIZATIONS AND INDIVIDUALS THAT MAKE THIS A DIVERSE AND THRIVING COMMUNITY. EVERY DAY RADIO MILWAUKEE AIRS NEW MUSIC, MILWAUKEE MUSIC, AND COMMUNITY STORIES PROMOTING THE WORK OF THOSE STRIVING TO MAKE MILWAUKEE A GREAT PLACE TO LIVE. RADIO MILWAUKEE ALSO HAS A VIBRANT ONLINE COMMUNITY VIA SOCIAL MEDIA AND AN ACTIVE WEBSITE WITH COMMUNITY CALENDARS. RADIO MILWAUKEE CAN BE HEARD AROUND THE WORLD VIA ITS ONLINE STREAMING. HYFIN CONNECTS THE CULTURE WITH THE LATEST BLACK CULTURE NEWS, PODCASTS AND MORE. HYFIN BROADCASTS ON-AIR AT 88.9FM HD2, ONLINE AT HYFIN.ORG AND VIA THE 88NINE AND HYFIN MOBILE APPS.
