SUBJECT: SS-2024-582: Wedeco UV Disinfection System: PW: Xylem: NTE \$1,850,000.

BACKGROUND:

This is a standardization sole source request, due to the fact that Xylem is the manufacturer of the one known, qualified ultraviolet (UV) disinfection system that can be installed and implemented into the existing channels and building at the West Boise Water Renewal Facility without significant structural modifications to the existing building.

Xylem UV disinfection products are currently being used at the West Boise Water Renewal Facility and PW staff is trained on the general use and maintenance of the Xylem UV disinfection products. A contract will be presented for Council approval once the sole source has been established.

RECOMMENDATION: Finance and Administration and Public Works Departments recommends approval of a sole source standardization and authorization to procure Wedeco Duron UV Disinfection System through Xylem Water Solutions USA be approved for execution in an amount not to exceed \$1,850,000. Cost variances may occur as contractor modifications may be necessary during construction.

FINANCIAL IMPACT:

Department has confirmed sufficient funding is available for this obligation.

**A RESOLUTION APPROVING A SOLE SOURCE PROCUREMENT SS-2024-582
STANDARDIZATION TO WEDECO DURON UV DISINFECTION SYSTEM,
BETWEEN THE CITY OF BOISE (PUBLIC WORKS) AND XYLEM WATER
SOLUTIONS USA; APPROVING AUTHORIZATION TO STANDARDIZE AND
PROCURE; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Xylem Water Solutions USA is the only is the manufacturer of the one known, qualified ultraviolet (UV) disinfection system that can be installed and implemented into the existing channels and building at the West Boise Water Renewal Facility without significant structural modifications to the existing building; and

WHEREAS, Notice of Intent to Award a Sole Source Procurement to Xylem Water Solutions USA was published in the Idaho Statesman on July 21, 2024; and

WHEREAS, Finance and Administration and Public Works Department staff recommend approval of a sole source standardization and authorization to procure SS-2024-582: Wedeco Duron UV Disinfection System, from Xylem Water Solutions USA, not to exceed \$1,850,000.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF
THE CITY OF BOISE CITY, IDAHO:**

Section 1. That SS-2024-582 Wedeco Duron UV Disinfection System by and between the city of Boise City and Xylem Water Solutions USA, is hereby approved as a sole source procurement.

Section 2. That authorization to procure SS-2024-582 Wedeco Duron UV Disinfection System by and between the city of Boise City and Xylem Water Solutions USA, not to exceed \$1,850,000.00, is hereby approved.

Section 3. That this Resolution shall be in full force and effect immediately upon its adoption and approval.
