Re: Onondaga County Correctional Facility

Dear Chairman Riley,

I received your correspondence dated February 3, 2023, and the materials and information requested are provided based upon the resources and data available to this office.

We understand the legal authority that the Commission holds relative to the minimum standard regulations for the care, custody, correctional treatment, supervision, discipline, and other correctional programs for all persons confined in local correctional institutions. Regarding the consolidation of the incarcerated population in Onondaga County into the Justice Center, it is understood that subject to inspection the Commission can close any facility which is deemed unsafe, unsanitary, or inadequate in its separation of prisoners as required by law. We understand the legal parameters and believe that recent local legislative actions will assist the Sheriff in meeting the aforementioned statutory requirements.

As the Commission communicated to the County in facility Minimum Standard reviews in 2021 and 2022, that while it understands the Justice Center has staffing issues, the facility lockdowns leading to the deprivation of essential services are unacceptable. The Commission has repeatedly cited these lockdowns as Minimum Standards violations and considered them a blanket punishment for the entire incarcerated population in the reported findings. The Justice Center continues to lose personnel to retirement and those choosing to leave the public safety sector. As a result, there were 69 partial or total shift lockdowns of the entire facility in 2022 and there is no immediate solution for this staffing predicament in 2023. This situation is one that is pervasive throughout the state, however, we have a resolution in our county that other counties do not. By combining the incarcerated population and staff into the Justice Center, the Sheriff will have increased ability to comply with all Minimum Standard regulations including HALT Act legislation, the Hurrell-Herring settlement agreement, and the centralized resources to ensure more streamlined health services through the contracted vendor.

The Justice Center can house the combined population and still have additional cells available. Upon completion of your evaluation of the facility, however, if a determination is made that the Justice Center is incapable of holding the entire population, any additional population will be boarded out to correctional facilities in other counties. In the long term, if the population remains elevated, considerations for the construction of a fourth Justice Center tower will be revisited.

Pursuant to Correction Law sections 44(4) and 46(1), the requested information follows:

- The abolishment of the Correctional Facility positions occurred after a vote of the Onondaga County legislature during the February 7, 2023, session (see enclosed). This simply signals the authority to move forward, not an intention to do so without a detailed timeline of events which considers the needs of all stakeholders. The resolution that was passed requires the Sheriff to provide a merger plan to the Legislature by February 28, 2023. Additionally, I have enclosed a conceptual overview merger plan from this office. A detailed description of Onondaga County's plan to close the Onondaga County Correctional Facility, to include a detailed timeline with relevant milestones, is an expectation from all stakeholders which can only be provided by the Sheriff's Office.
- Approximately 20 Correctional officers have transferred to the Justice Center since the end of 2021. The
 available resources necessary to affect a larger transition are already in place and the Justice Center
 administrative staff have prepared for this outcome for several years.
- The healthcare contract was awarded to Wellpath on January 1, 2023. The continuity of healthcare services for the incarcerated population will occur and be strengthened by having all resources in one centralized location.
- As you know, the Justice Center began a window fortification project in 2022 in order to prevent the introduction of contraband into the facility. As the project continues into 2023, the County stands ready to assist with additional resources to expedite the completion of the project if necessary.

In consideration of the above, I am confident that our plan will meet the needs of the incarcerated population, the Sheriff and his staff, the Commission and the citizens of Onondaga County.

Concept Overview – Merger of Custody and Correction

February 14, 2023

I. Background

The Onondaga County Sheriff's Office is responsible for the care and custody of incarcerated individuals committed by law to the custody of the Sheriff. Historically, within Onondaga County, sentenced individuals have been housed at the Jamesville Correctional Facility (Correction Division) and unsentenced individuals at the Onondaga County Justice Center (Custody Division). Distance between the facilities and differences in employee representation/terms and conditions of work have served as a challenge in maximizing the efficiency and effectiveness of the Sheriff's Office's detention operations.

The COVID-19 global pandemic, the national disinterest in public safety careers and the HALT Act had a profound impact on public safety agencies, especially the Sheriff's Correction and Custody Divisions. Decimated civil service eligible lists and a wave of staff resignations/retirements has presented an impossible challenge to continue independently staffing both facilities, even in the face of significant decreases in the overall immate population. Current staffing at the Justice Center is not nearly sufficient to maintain independent operations and the ability to hire new sworn personnel in impactful numbers does not exist.

Merging the Correction and Custody Divisions is the only viable option to ensure continuity of operations both in the short and medium length terms. Immediate action is essential to effectively manage continued staffing shortages. The current time is optimum, considering that the numbers of staff and incarcerated individuals is at the lowest point in recent memory.

A single entity would address current staffing challenges, legal challenges, provide essential services to the incarcerated population and save millions of taxpayer dollars. Consolidation will also generate a number of ancillary benefits to all stakeholders, including:

- a more cohesive and effective operation;
- consistency in services and programs for incarcerated individuals;
- parity in employee compensation;
- increased vertical and horizontal career development opportunities for staff;
- provision of a single point of contact for the families of incarcerated individuals, legal representatives, inmate advocates, program providers, service providers and vendor;
- ability to deploy personnel and equipment resources where necessary;

II. Merger Steps

- 1. By April 1, 2023, all employees in the Correction Division will have moved to the corresponding, rank, grade and pay rate in the Custody Division. Staff will be given the opportunity to join the DSBA bargaining unit.
 - a. All civilian titles currently in the CSEA Correction Unit will continue to be represented by CSEA.

- 2. The CSEA title of "Senior Correction Officer" was abolished, and employees in that title will be moved to the corresponding DSBA rate for "Deputy Sheriff Custody" based on completed years of service.
- 3. Approximately 20 staff members have previously transferred from Correction to Custody so the process of movement of staff and incarcerated individuals has already been established.
- 4. Utilizing personnel from the Sheriff's Office Staff Development Section, train Correction Divison staff in groups on their pass days or off shift, until all staff have completed the classroom portion of the training. The training should consist of policy/procedures review, radio procedures, facility design/downtown complex layout and familiarization, emergencies, union introduction and any other topics unique to working inside the Justice Center. This should not take more than two days to complete.
- 5. Once all classroom training is completed, the same process for field training Correction Division staff in the Justice Center housing units will begin. Since previous Correction staff have quickly assimilated into the Custody staff following an abbreviated length of training, and since both staff already work in the same field of corrections under the same NYS laws, guidelines and regulations, the length of time required for staff to be ready to work alone should not typically exceed two, four-day workweek rotations.
- 6. Following 1-2 days of classroom training and 8 days of field training, begin the transfer of the incarcerated population from Jamesville to the Justice Center. The Transport Section of the Custody Division has several mass transit vehicles including a 29-person bus used when transferring to the state corrections system. A balance must be struck between maintaining ongoing Transport duties and the transfer of the incarcerated individuals. With this is mind, groups of approximately 8-10 incarcerated individuals, minimally twice a day and including weekends, the current population of 130 could be completely transferred within approximately two weeks. Additionally, the Correction Division has trained transport staff who can assist in these mass transfers.
- 7. Wellpath, Inc. was awarded the healthcare contract for Onondaga County and began providing services in the correctional facilities on January 1, 2023. Wellpath is a past provider and is the largest correctional healthcare provider in the nation. The continuity of healthcare services will continue during the merger with the Justice Center since the IIS (inmate information system) and the medical records are on networks that are remotely accessible. Transfers occur between the facilities on a routine basis and the medical supplies, pharmaceuticals and administrative offices are centrally located at the Justice Center. It is also a quicker EMS response to the Justice Center and if the patient requires hospital services, most are minutes away from the downtown complex.
- 8. With guidance from the Commission, the Justice Center began a window fortification project in 2022 as another step to prevent contraband flow into the facility. With over two months to complete the merger and while it is underway, the window project can continue. As each pod is completed, the incarcerated population can be assigned while the work continues into the next pod. The county can devote additional resources to the project to expedite completion if necessary.

9. There are currently enough cells available for both sexes and all classifications in the Justice Center to house the entire combined incarcerated population. If, however, the State Commission of Correction assessment finds that a small number of incarcerated individuals would exceed the Justice Center maximum facility capacity in any given classification, then that small group should be boarded out to an adjoining county.

PROVIDING FOR VARIOUS PERSONNEL CHANGES

WHEREAS, the personnel changes authorized herein have been approved by the Onondaga County Commissioner of Personnel, Chief Fiscal Officer, County Executive and the Ways & Means Committee of the County Legislature; now, therefore be it

RESOLVED, that the County Legislature hereby authorizes the abolishment and creation of various positions as set forth in Schedule A on file with the Legislature, effective April 1, 2023, the date on or before which the Onondaga County Sheriff's Office's plan detailing the means, methods, and manner of consolidating and merging Jamesville Correctional Facility and Onondaga County Justice Center personnel, incarcerated individuals, equipment, and resources at the Onondaga County Justice Center ("Consolidation Plan") is to be fully effectuated and implemented ("Implementation Date"), or any reasonable extension to said Implementation Date authorized by the County Executive, consistent with New York State Civil Service Law; and, be it further

RESOLVED, that the County Legislature hereby further authorizes the transfer of various functions pursuant to Section 70.2 of New York State Civil Service Law, as set forth in Schedule B on file with the Legislature, effective April 1, 2023, the Implementation Date of the Consolidation Plan, or any reasonable extension to said Implementation Date authorized by the County Executive, consistent with New York State Civil Service Law; and, be it further

RESOLVED, that the Commissioner of Personnel is hereby authorized to make any administrative corrections as may be reasonably needed to effectuate the intent of this Resolution.

RESOLUTION NO. 7

REQUIRING THE ONONDAGA COUNTY SHERIFF'S OFFICE PREPARE AND SUBMIT A DETAILED PLAN REGARDING THE CONSOLIDATION OF THE JAMESVILLE CORRECTIONAL FACILITY AND ONONDAGA COUNTY JUSTICE CENTER

WHEREAS, this Onondaga County Legislature has deemed it necessary to merge Jamesville Correctional Facility and Onondaga County Justice Center personnel in order to better provide for and protect the civil liberties of incarcerated individuals through sufficient staffing of the Onondaga County Justice Center; and

WHEREAS, in furtherance of said merger/consolidation, and consistent with the Onondaga County Sheriff's responsibilities and duties, this Onondaga County Legislature desires the timely development and dissemination of a plan detailing the means, methods, and manner of consolidating and merging Jamesville Correctional Facility and Onondaga County Justice Center personnel, incarcerated individuals, equipment, and resources at the Onondaga County Justice Center, and responding to the February 3, 2023 letter from the New York State Commission of Correction ("Consolidation Plan"); now, therefore be it

RESOLVED, that this Onondaga County Legislature does hereby direct and require the Onondaga County Sheriff's Office to prepare and submit to the New York State Commission of Correction, on or before February 28, 2023, a Consolidation Plan, which Consolidation Plan shall be fully effectuated and implemented on or before April 1, 2023 ("Implementation Date"); and, be it further

RESOLVED, that the Onondaga County Executive, in his discretion, may reasonably extend the Implementation Date.

LOCAL LAW NO. - 2023

A LOCAL LAW AMENDING THE ONONDAGA COUNTY CHARTER AND ADMINISTRATIVE CODE REGARDING THE ONONDAGA COUNTY SHERIFF

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ONONDAGA, AS FOLLOWS:

Section 1. Findings. The Onondaga County Sheriff is tasked with delivering services as provided for within the Onondaga County Charter, Onondaga County Administrative Code and applicable laws. The nature and scope of services provided by the Sheriff has evolved due to changes in law and policy, resulting in shifting incarcerated individual population trends and the resultant need for closure of the county penitentiary facility. To that end, this Onondaga County Legislature hereby desires to amend the Onondaga County Charter and Administrative Code to enable the Sheriff to address these changes and more effectively coordinate and deliver needed services, allowing for delivery of higher quality services and better allocation of limited resources for the benefit of the residents of Onondaga County.

Section 2. The Onondaga County Charter, being Local Law No. 1 of 1961, as previously amended, hereby is further amended to strike Section 1003 in its entirety and substitute the following:

Section 1003. CHIEF DEPUTY OF CUSTODY.

There shall be a chief deputy of custody, under the supervision of the Office of the Sheriff, who shall be the head of the county jail, appointed by the Sheriff on the basis of administrative experience and qualifications for the duties of the office, consistent with requirements of applicable law. The chief deputy shall have and exercise all the powers and duties now or hereafter conferred or imposed upon a chief administrative officer of a county jail by any applicable law. Such officer shall perform such other and related duties as shall be required or delegated to him by the Sheriff, the County Executive, or County Legislature.

Section 3. Section 10.03 of the Onondaga County Administrative Code, being Local Law No. 1 of 1975, as previously amended, referenced herein as the "Administrative Code", hereby is further amended to insert the following language at the beginning of Section 10.03 (b):

The Sheriff shall appoint a chief deputy of custody in a manner consistent with applicable laws, including Section 1003 of the Onondaga County Charter. Except as may otherwise be provided in the Charter or this Code, the chief deputy shall: be responsible for the operation, maintenance, supervision, repair, custodial care and security of the Onondaga County jail; be responsible for the receipt, housing, care, custody, control and employment of all inmates sentenced or assigned to the jail or otherwise housed therein; initiate, implement and coordinate programs for the rehabilitation, education and training of inmates sentenced or assigned to such jail or otherwise housed herein; initiate, implement and coordinate programs for the distribution of food and other products manufactured or produced within such jail; and have all the powers and perform all the duties now or hereafter conferred or imposed by law.

Section 4. The Administrative Code is further amended to strike Section 10.04 in its entirety.

Section 5. The Administrative Code is further amended to strike the word "Corrections" from Section 3.03B (2).

Section 6. Except as specifically amended herein, the Onondaga County Charter and Administrative Code shall remain in full force and effect. This local law shall be construed in such a way so as not to diminish or curtail powers held by any elected official within County government.

Section 7. Severability. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by a court of competent jurisdiction to be invalid, the judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph or section or part hereof directly involved in the controversy in which the judgment shall have been rendered.

Section 8. Effective Date. This Local Law shall take effect immediately and shall be filed consistent with the provisions of New York State Municipal Home Rule Law.
