KDNK's mission is to connect communities and the world through community access radio. We do this through our 9 signals in a challenging rural, mountain environment, digital streaming, our website, and newsletters. We have over 75 volunteer music DJs and 24 public affairs host DJs. We are very unique in that every weekday we live a unique, established public affairs show produced and broadcast by volunteers. We diligently reach out to our listening communities in person through events and pop-up tabling. We reached audiences across the country by facilitating two high school graduations in a radio drive-through format during the pandemic. We reached a new video audience by radio broadcasting a new initiative at Steve's Guitars with Grassroots TV to stream live concerts. We broadcasted hours of COVID information with updates in multiple counties and published a specific web page in English in Spanish for COVID information. We broadcast youth plays from the Stage of Life Theater made for radio that was originally scheduled to be performed live on stage.

Welcoming one and all to our airwaves has provided numerous opportunities for collaboration resulting in excellent programming. Some examples are CORE Imagine Climate, SOL Theatre Radio Plays, Women's VOICES Origin Stories, Wilderness Workshop/ACES Naturalist Nights, 50th Mountain Fair Radio Shows and Live Broadcast, Carbondale Historical Society This I Remember Shows, True Nature Summer Concert Series, Aspen Art Museum Mid-Summer Blowout, Carbondale Creative District Express Yourself. Partnering with local governments has helped us provide timely information regarding public health, wildfires, flash floods, mudslides, and highway closures. 100's of organizations and causes have been given voice through KDNK. We collaborate with Andy Zanca Youth Empowerment program to provide 6 hours of air time for youth and therefore network and collaborate with every primary and secondary school within every listening area we cover. This youth programming is the greatest example of interaction with a vast amount of Hispanic/Latinx youth and their parents.

We continue to have measurable increases in collaborative efforts that serve the community and at the same time provide excellent programming content. The youth radio public affairs program continues a series exploring services available to LGBTQ youth in our listening area. The DJ logs for our youth programming are both in English and Spanish. We are partnering with 7 local media outlets including the all Spanish-speaking station, Radio tri-color in a grant-funded study starting now and continuing for 6 months to authentically and comprehensively learn how we can best serve and provide content to the over 30% Hispanic/Latinx population. We have 6 Spanish-speaking volunteer DJs, including an Afro Caribbean DJ originally from Belize. We fiscally sponsored a grant to assist a blind volunteer to produce our award-winning podcast called The Tactile Traveler to empower blind and low vision people to explore the world and help the sighted see the world in a new way. We continued our longstanding award-winning series Immigrant Stories which features personal narratives about people of all backgrounds who have experienced immigration. We broadcast two to six hours a week of bilingual programming, and have 3, two-hour, Latin music genre shows per week. We edited Spanish-speaking audio submissions for the Stories of Climat Change mural project.
