IT STAKED STRONG CLAIMS TO BEING THE GO-TO SOURCE OF JOURNALISM, INFORMATION AND CONVERSATION IN THE CHARLOTTE REGION. THE STATION BECAME A HUB FOR BREAKING NEWS VIA THE WORK OF THE STATION'S GROWING LOCAL NEWSROOM; AN INVESTIGATOR OF POLITICAL WRONGDOING AND THE MISSTEPS OF REGIONAL LEADERS; A FORUM FOR NUANCED EXPLORATIONS OF SUCH DIFFICULT LOCAL TOPICS AS AFFORDABLE HOUSING, HOMICIDES AND SEXUAL ASSAULT;
