

## Northern Public Radio Spring Sweepstakes Rules & Regulations

NO PLEDGE NECESSARY TO ENTER.

Pledging does not increase the chances of winning. Void where prohibited. Open only to legal residents of the 50 states of the U.S. (including the District of Columbia) and Canada, 18 or older.

The NYC Sweepstake begins at 7:01 AM CDT on Thursday, April 23, 2015. The deadline for entry into the sweepstakes is 9:59:59 AM CDT. A pledge in any amount within these deadlines results in an automatic entry. Northern Public Radio Sustaining Members are automatically entered into all sweepstakes. 1. All entries must be received by 9:59:59 A.M. CDT on 4/24/15.
2. Winners will be selected in a random drawing on 4/24/15 at Northern Public Radio, supervised by management of Northern Public Radio, whose decisions regarding winners will be final.
3. The winner will be posted at [www.northernpublicradio.org](http://www.northernpublicradio.org) and announced on WNIJ and WNIU on 4/24/15 and will remain posted no less than 5 days.
4. Employees of Northern Public Radio and members of their households along with those involved in the development, production (including prize donors), implementation and distribution of this sweepstakes are ineligible for sweepstakes prizes.
5. Limit one (1) entry per person, per email address, and per household for the duration of the Sweepstakes Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. Once submitted, entries become the sole property of Northern Public Radio and will not be returned.
6. Winners will be notified by phone, mail, and/or email. If a potential winner cannot be reached after 10 days from first notification attempt, or if an entrant is found to be ineligible, or prize notification is returned as undeliverable, such prize will be forfeited and an alternate winner selected.
