Partnerships are nothing new for WVPE Public Radio. The station has worked with other Michiana non-profits to produce community events for years. Recently, new organizations have been created to serve the area on the Internet.

WVPE strives to inform, entertain and inspire the public through its Web presence as well as its on-air programming. To this end, WVPE gathered and published lists of events and resources at wvpe.org. As other Michiana organizations have surpassed some of WVPE's offerings, the station has supported them in order to better serve the community. ArtsEverywhere.com is a good example of an online database and tool that goes beyond what WVPE's Web site could offer. WVPE began its partnership with the arts and culture event site in 2006.

WVPE is now proud to announce new partnerships with Make a Difference Michiana, the Michiana Green Pages and the Sustainable Business Network. Make a Difference Michiana "provide a one-stop website for you to find all the information you need about non-profit organizations in the Michiana area." The Michiana Green Pages "connects [Michiana] with socially and environmentally responsible efforts in our area that provide green products and services." The Sustainable Business Network "inform[s] and connect[s] leaders in business, industry, education and community about the opportunities available to them through The Sustainable Business Round Table and Sound of the Environment."

Spring Green Campaign

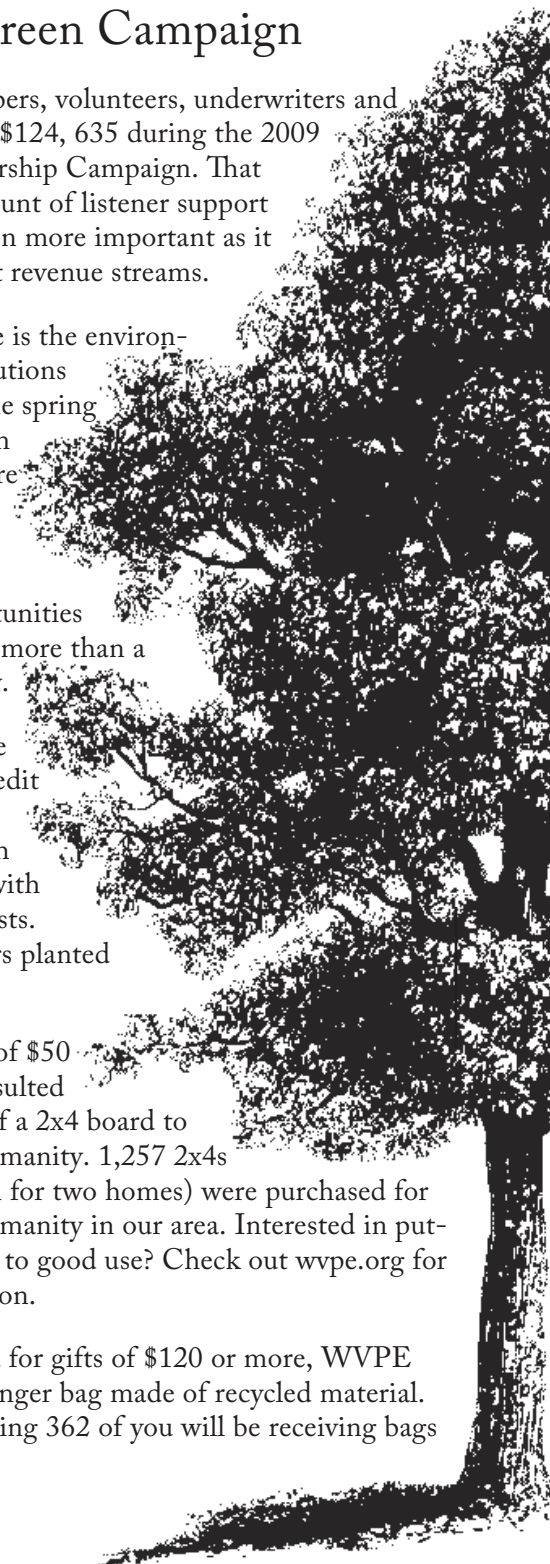
WVPE's members, volunteers, underwriters and partners raised \$124,635 during the 2009 Spring Membership Campaign. That impressive amount of listener support has become even more important as it offsets deficient revenue streams.

Also impressive is the environmental contributions made during the spring campaign. In an effort to be more environmentally-friendly, WVPE offered listeners opportunities to sustain even more than a radio frequency.

For each pledge made with a credit card, a tree was planted through a relationship with American Forests. WVPE listeners planted 986 trees.

Contributions of \$50 or more and resulted in a donation of a 2x4 board to Habitat for Humanity. 1,257 2x4s (almost enough for two homes) were purchased for Habitat for Humanity in our area. Interested in putting those 2x4s to good use? Check out wvpe.org for more information.

As a thank-you for gifts of \$120 or more, WVPE offered a messenger bag made of recycled material. A record-breaking 362 of you will be receiving bags this spring.
